Narrative:

On February 28, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matt Armstrong (Armstrong) received the Strongsville Police Department (SPD) Computer Aided Dispatch (CAD) report from SPD Detective Bureau Secretary Carrie Destro. The report was associated with the October 18, 2022, emergency call which resulted in Bryan Bailey being transported to the Southwest General Medical Center. Detective Sergeant (Sgt.) Gregory Cravatas (Cravatas) indicated the CAD report was the only document generated by the police department in reference to the incident.

SA Armstrong reviewed the report and noted the following:
