Narrative:

On October 22, 2023, Gallia County Sheriff Matt Champlin (Sheriff Champlin) requested Ohio Bureau of Criminal Investigations (BCI) Crime Scene (CSU) and Special Investigations (SIU) units respond to the 16000 block of State Route 160, Vinton, Ohio, in reference to an Officer-Involved Critical Incident (shooting) involving Gallia County Sheriff's Office (GCSO) deputies and Roger Meade (Meade). The incident occurred in a pull behind style camper parked near the border of two properties identified on the Gallia County Auditor's website as parcel numbers 01500140501 and 01500140301. There does not appear to be a residential address associated with either parcel.

It was reported to BCI that GCSO Deputy	(Deputy	engaged in an
exchange of gunfire with Meade near the fi		
property while Deputy was attempting	g to serve an arrest warra	nt on an uninvolved
subject believed to be staying in the campe	er. Deputy was re	eportedly uninjured,
however he was struck by possible ricochet	or shrapnel from Meade's	gunfire. Meade was
struck by gunfire in the upper chest area an	d succumbed to his injurie	es on scene. Deputy

additional officers on scene during the incider	nt.	

Erin McMillin (McMillin) was reportedly inside the camper during the incident and had been transported from the scene. BCI was informed McMillin was facing no charges as a result of the incident and had verbally agreed to await BCI's arrival to provide a witness statement.

BCI Special Agent Mathew Austin (SA Austin) was designated the CSU lead agent and BCI Special Agent Craig Call (SA Call) was designated the SIU lead agent.

BCI CSU Special Sarah Taylor (SA Taylor) assisted SA Austin with the scene and BCI SIU Special Agents Andy Russell (SA Russell), Jimmy Poole (SA Poole), and Chad Holcomb (SA Holcomb) responded to assist with the investigation.
