

Narrative:

On July 14, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent James Poole (SA Poole) received copies of the medical records for Joy Graham (Graham), from Southeast Regional Hospital (Southeast Hospital). The medical records were obtained via an Investigative Subpoena from the Guernsey County Prosecutor's Office through the Guernsey County Municipal Court. These records are regarding the injuries of Graham as a result of an Officer-Involved Critical Incident which occurred on June 24, 2022. A copy of these records will be maintained electronically within the case file. Please refer to the records for specific details.

On July 21, 2022, SA Poole reviewed the medical records for Graham. Graham was transported via emergency squad to Southeast Hospital on June 24, 2022, with traumatic injuries from multiple gunshot wounds. The records indicate, "
