Narrative:

On Monday, April 12, 2021, the Bureau of Criminal Investigation (BCI) Special Agent Supervisor (SAS) Kevin Barbeau received the below referenced thumb drive from Drew Evans, St. Ann's Safety and Security Director. The thumb drive contains Emergency Department (ED) video footage (no audio) requested by BCI in order to investigate an Officer-Involved Critical Incident (OICI) which occurred at St. Ann's Hospital (500 South Cleveland Ave, Westerville, Ohio) on this date. It was learned Columbus Police Department (CPD) officers were taking Miles Jackson (patient; subject involved) into custody at St. Ann's Hospital ED room. A struggle ensued and CPD officers and St. Ann's (armed) Security Officers discharged their duty weapons. Miles died from apparent gunshot wounds.

SAS Barbeau also provided the attached letterhead to Evans in order to memorialize the request. The footage was reviewed by investigators during the on scene investigation. The footage includes the nurses station area and/or ED hallway. This footage captures this general area to include the exterior of the ED room where the incident took place.

The following was noted within the video:

- Jackson was brought into St. Ann's by medics, on a gurney, and in the presence of Westerville Police Department officers and EMS.
- Columbus Police arrive and WPD departs following the exchange of custody.
- Nurses can be seen peering into the room.
- One CPD officers exits (crawls) the room and draws his duty weapon.
- St. Ann's armed security officers arrive followed by an additional CPD officer (female), who transitions to a taser.
- The taser appears to be deployed followed by what appears to be gunshots from the hallway area, which filled the area with smoke.

It should be noted the video collected was not time stamped and the above referenced information is only a highlight of items as the video was three (3) hours long. The thumb drive was placed in the physical case file and the video should be reviewed for additional details.
