Narrative:

On June 26, 2023 at approximately 1144 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent Dave Hornyak interviewed Justin Tudor in regard to an Officer-Involved Critical Incident that occurred the evening of June 17, 2023. SA Hornyak contacted Mr. Tudor after being advised by the Lebanon Police Department that Tudor had called to advise he personally knew case subject, Dione Kellum who had previously told him of his desire to commit "suicide by cop."

Mr. Tudor stated to BCI that he has known Dione Kellum since 2018 and was incarcerated with him in the Warren County Jail from approximately February – April 2022. During that time, Kellum told Tudor that after he got out, he would force the police to shoot him rather than ever go back to jail. Kellum was incarcerated for aggravated possession of drugs.

Tudor also said that Kellum "...loved firearms" and had tried in the past to get Tudor to provide him with weapons. Tudor stated that he always declined to do so.

The interview ended at approximately 0953 hours.

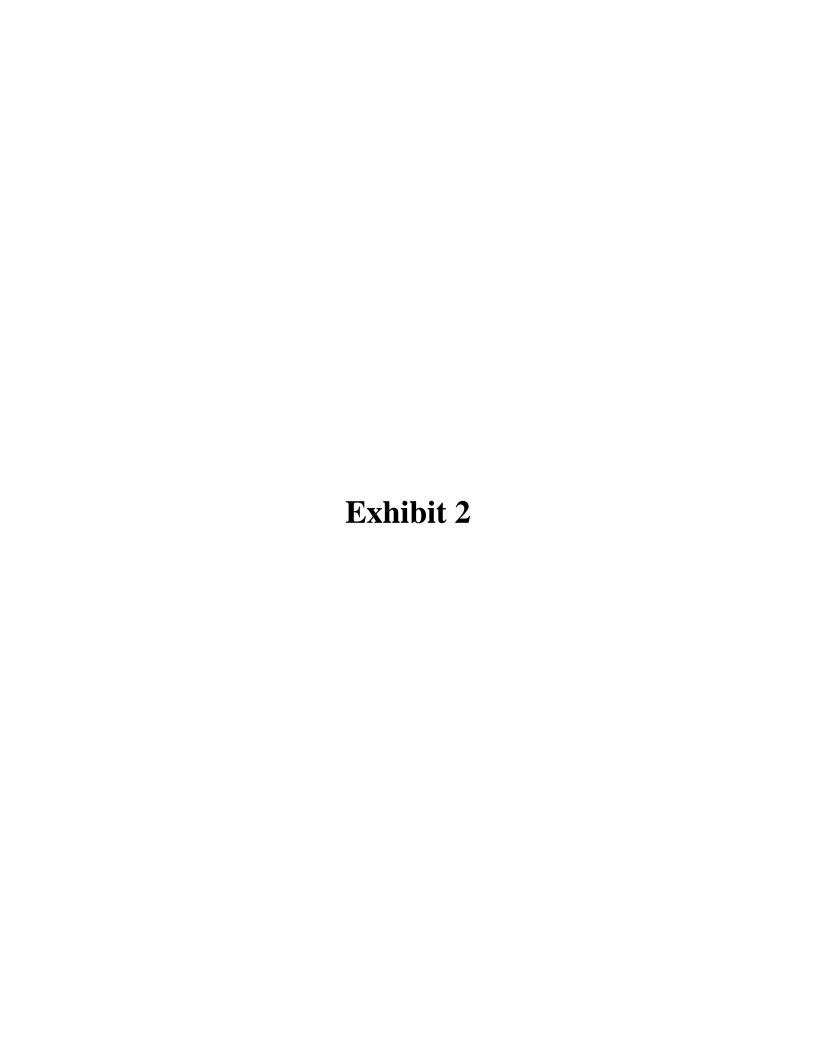
