#### Narrative:

On January 6, 2023, the Ohio Bureau of Criminal Investigations (BCI) was requested by the Goshen Township Police Department in Clermont County, Ohio, to investigate the facts and circumstances surrounding an Officer–Involved Critical Incident (OICI). The OICI occurred at 1785 State Route 28, Lot 419 AA, Goshen Township, Ohio. Dewald reportedly committed suicide while Goshen Township police officers were attempting to apprehend him for a felony warrant.

BCI Special Agent Steven Seitzman (SA Seitzman) responded to the Tri-Health Bethesda North Hospital, where Dewald lay deceased in the emergency room. Dewald's clothing had already been removed. Trauma Program Manager Katie Stegman, RN, MSN, CEN, TCRN, and EMT-P, turned over the clothing to law enforcement. Goshen Township Police Detective Christopher McMillan placed the clothing items in paper bags while SA Seitzman took an inventory.

SA Seitzman took photographs of Dewald with Ms. Stegman's permission.

The evidence was collected and transported to the OICI scene, where it was released to BCI Crime Scene Unit Special Agent Kevin Wagner. The BCI Inventory/Receipt form documenting the chain of custody is attached below. Also attached are the photographs of Dewald taken by SA Seitzman.
