#### Narrative

During the course of this investigation, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Jason Snyder (SA Snyder) received requested records and recordings from the Celina Police Department (Celina PD). SA Snyder had previously requested all dispatch records, audio recordings (radio, 911, and phone), mobile data terminal (MDT) communications, and any other dispatch/communications-related information for the following date and time period surrounding this incident on August 25, 2023. As a result of that request, the following items were received and reviewed:

# Computer Aided Dispatch (CAD) Records:

SAS Stranahan reviewed dispatch notes and a CAD log from the Mercer County Sheriff's Office for August 25, 2023. Investigation revealed the following:

## Radio Traffic Recordings:

SAS Stranahan reviewed the radio recordings received from the Celina Police Department. The radio traffic is broken down into 24 separate files. The radio traffic also does not contain the voice of the dispatcher. It only contains the voice of the officer. For the purposes of this investigative report, SAS Stranahan will only discuss radio traffic deemed pertinent. Copies of the radio traffic received from the Celina Police Department have been placed in this case file. Investigation revealed the following:

1. 23\_XCELINPD\_2023\_08\_25\_02\_22\_24

A male officer who identifies himself as unit number 11 contacts dispatch via radio and said "I'll be out at East View, back at the pond, 60A [suspicious vehicle]."

2. 22\_XCELINPD\_2023\_08\_25\_02\_24\_58

An unidentified male officer broadcast "I'll be out with him."

3. 21\_XCELINPD\_2023\_08\_25\_02\_25\_37

A male officer broadcast "He's taking off. He's Taking off."

Another officer asked "Which way."

An officer broadcast "Shots fired."

An officer broadcast "He tried to strike me."

Another officer broadcast "Get Coldwater, Get St. Marys and Get the County out here." [SAS Stranahan could also hear an audible siren in the background of this radio transmission.]

An officer broadcast "Signal 99."

An officer asked "Where's he at?"

An officer broadcast "Vehicle is stopped. Get, get up here now. PD get some more units here now.

4. 18\_XCELINPD\_2023\_08\_25\_02\_27\_37

An officer broadcast "Deputy, let the County know we need a shield out here.

5. 16\_XCELINPD\_2023\_08\_25\_02\_28\_46

An officer broadcast "PD, get me a squad out here on standby."

6. 14\_XCELINPD\_2023\_08\_25\_02\_29\_21

An officer broadcast "Go ahead and tell the squad to standby right at the entrance to the park."

7. 10\_XCELINPD\_2023\_08\_25\_02\_31\_14

An officer broadcast "PD, get the squad back here to the pond right away. We got a gunshot victim."

8. 08\_XCELINPD\_2023\_08\_25\_32\_36

An officer requested dispatch contact "Unit 2 [Assistant Chief]."

9. 07\_XCELINPD\_2023\_08\_25\_02\_33\_04

An officer asked "PD. Where's the squad at?"

10. 05\_XCELINPD\_2023\_08\_25\_02\_34\_14

An officer said "PD. Tell the squad to come back by the pond."

11. 02\_XCELINPD\_2023\_08\_25\_02\_37\_20

An officer asked "PD. Did you make any contact with Unit 1 or Unit 2 yet [Chief and Assistant Chief]

### 911 Calls:

There were no 911 calls regarding this incident.

## Other Phone Calls (other than 911):

SAS Stranahan reviewed telephone calls that were provided by the Celina Police Department. For the purposes of this investigative report, SAS Stranahan will only discuss radio traffic deemed pertinent. Copies of the radio traffic received from the Celina Police Department have been placed in this case file. Investigation revealed the following:

1. 20\_SIP\_2\_2-23\_08\_25\_02\_26\_13

A female dispatcher called an officer and asked where they were at. The officer responded and said they were at "East View by the pond."

2. 19\_Sip\_Trunk\_3\_2023\_08\_25\_02\_27\_23

This was a conversation between a male and female dispatcher. The female dispatcher asked the male dispatcher [Celina PD] what they had going on. The male dispatcher stated that it was a "60 [suspicious] that turned into shots fired taking

off." Muffled radio traffic and be heard in the background. The female dispatcher asked what the officers on the radio said. The male dispatcher replied and said the officers were requesting a "shield."

3. 15\_SIP\_Trunk\_2\_2023\_08\_25\_02\_29\_16

The Celina PD dispatcher contacted the fire department and requested a "squad" to respond to East View park and be on standby due to shots being fired.

4. 09\_SIP\_Trunk\_2\_2023\_08\_25\_02\_32\_15

The Celina PD dispatcher called the fire department and asked if they had dispatched their ambulance. The fire department said they had not. The dispatcher then requested the ambulance respond to the East View park for a gun shot victim.

5. 04\_SIP\_Trunk\_2\_2023\_08\_25\_02\_34\_17

The Celina PD dispatcher placed a telephone call to Assistant Chief Harting. The dispatcher provided the Assistant Chief with the details of the incident know to the dispatcher. The Assistant Chief said he would be in route to the scene.
