Narrative:

On Monday, January 23, 2023, at approximately 1841 hours, the Ohio Bureau of Criminal Investigation (BCI) was requested by the Ohio Attorney General's Office Special Prosecutions Section to conduct an independent investigation of the facts and circumstances surrounding the October 18, 2022, death of a patient at Southwest General Hospital. The request indicated the patient's death was the result of police action. BCI Special Agent (SA) Matthew Armstrong was assigned as the lead investigator.
