On Tuesday, December 20, 2022, the Marion County Sheriff's Office and Marion Police Department requested the assistance of the Ohio Bureau of Criminal Investigation (BCI) with the investigation of an Officer Involved Critical Incident which occurred in LaRue, Marion County, Ohio. During the investigation, Special Agent Jason Snyder was provided with the personnel file of Marion County Sheriff's Deputy. On Friday, January 6, 2023, Special Agent Supervisor (SAS) Scott Stranahan reviewed Deputy special spersonnel file and noted the following:		
SAS Stranahan reviewed a file titled "Training Records for sold of the straining revealed this file contained training records and Deputy sold of Solio Peace Officer Training Commission (OPOTC) certificate. SAS Stranahan reviewed these documents and noted the following. Deputy straining attended the basic police academy at the Eastern Gateway Community College. Upon completion, Deputy was awarded an OPOTC certificate in August of 2014. There were also several documents which listed each training session/class Deputy has attended from August of 2014 through November of 2022.
