### Background:

On Thursday, 2022-12-29 at approximately 1314 hours, Barberton Police Department (BPD) – Detective Tony Memmer made telephone contact with Ohio Attorney General's – Bureau of Criminal Investigation (BCI) – Special Agent Charlie Snyder (Snyder). Memmer advised discovering a telephone voice message on his phone from Jason (last name unintelligible) from telephone number received on/about 2022-12-26 at 0838 hours. The message indicated Plants had received threats from decedent Zachary Zoran (Zoran) prior to the officer involved critical incident involving BPD. Snyder took the information and advised Memmer it would be followed up.

#### Actions Taken:

On Thursday, 2022-12-29 at 1400 hours, Snyder transmitted text message with Plants information to North East Major Case Response Team #4 members with basic information.

At 1410 hours, Snyder made telephone contact with Jason Plants and conducted an audio-recorded interview. Due to issues involving Plants, the contact was difficult to understand, inpart due to Plants' possible speech impediment.

Plants advised going to elementary through high-school with Zoran and graduated together. He indicated they had been friends, but that they had not had much recent contact until Christmas day. According to Plants, Zoran had complimented on photos and Christmas things on Plants' Facebook pages. Plants responded by asking Zoran how he was doing through Facebook Messenger. Plants indicated asking how Zoran was doing and Zoran replied, "...not to well..." and then requested Plants post a video of Zoran's mother and son apparently fighting. Plants indicated the video did not show the fighting and appeared only to capture images of a floor. Plants' indicated he could hear Zoran's mother yelling. Then Zoran began talking about an unknown person he called "Josh" who Zoran may have indicated was a drug dealer. As their communications went on through the day, Zoran began threatening to kill Plants and his family

as well as everyone Plants knows. Zoran also told Plants about possessing all types of weapons, brass knuckles, knifes, etc. Plants reported that he asked Zoran if he was threatening him. Plants indicated Zoran responded that he was going to kill Plants.

As their communications continued, Zoran began referring to Hell's Angles and Illuminati and continued threatening him and telling Plants that things he could do to him.

Plants indicated he did not feel comfortable with the threats. Plants indicated the threats were made on 2022-12-25 at 1422 hours. Plants further advised reporting the threats to the Stow Police Department. Plants did not have access to the indicated Stow Police Department report.

Plants identification and contact information was then confirmed. Plants advised his Facebook account is under "Jason Plants" and that the indicated screen shots should be available for review. Plants also agreed to provide access to his Facebook account if necessary and was willing to forward copies of that content if necessary to law enforcement.

Plants was advised his information would be reviewed and there likely would be additional future contact with him as result.

Plants then indicated the Barberton Police officers involved did a tremendous job and wanted to give them full credit for what they had to do and was aware they had no other choice.

The Plants contact concluded at approximately 1425 hours.

Note: At approximately 1440 hours, Snyder made telephone contact with Stow Police Department (SPD)—Records Section and spoke to Ms. April Dirker (Dirker) of that unit. Snyder requested SPD confirm Plants reporting reference and if possible forwarding the incident reporting to him. Dirker confirmed there was reporting, filed under incident number 22-20804. Further, Dirker agreed to transmit a scanned copy to Snyder with official agency e-mail request.

Note: At approximately 1511 hours, Dirker's e-mail with requested reporting was received. The indicated e-mail exchanges and attachment was uploaded into Matrix.

**Description:** 

On 12/25/22 at approximately 2112 hours, Jason Plants called to report threatening Facebook messages from Zachary Zoran.

When I arrived on scene, Jason stated Zachary, an old high school acquaintance of his, had commented on one of his Facebook posts. Jason had messaged Zachary asking how he was. Zachary sent Jason a video of the ground. The audio in the video appeared to be Zachary's mom and son arguing.

Zachary told Jason to post the video or he would "shoot you multiple times in the chest". Zachary continued threatening Jason stating "I have multiple weapons in my possession....knifes. Guns, brass knuckles" and "you cant allow anyone to know I threatened you or I'll kill everyone that you love. Merry Christmas". When Jason asked Zachary if he was threatening him, Zachary stated "It's not a threat Jason I legit will kill you and everyone you love with my crew".

Jason stated he was afraid Zachary would cause him serious physical harm. He provided a written statement.

On 12/26/22, it became known to officers that Barberton Police had an interaction with Zachary. Zachary was shot and killed by Barberton Police

No charges will be filed, given the circumstances.
