WHEREAS, the meeting and exchange of information between the County and AMS led to a letter dated September 17, 1997, in which the County notified AMS that the County had obtained sufficient information about the AMS Facility for use in the County's 1997 annual update of its plan for responding to emergencies involving releases of hazardous materials.

NOW THEREFORE, without adjudication or admission of any issue of fact or law, and with the agreement of the parties and the reservation by each of all rights, claims and defenses, this matter is hereby DISMISSED.
