This action comes to this Court by appeal under R.C. §1509.37. Appellants brings the instant action based upon an order by the Oil & Gas Board of Review (hereinafter "Board"), dated July 9, 1986. That order granted Atlas Energy Group, Inc. a permit to operate a brine injection well.

Upon review of the case <u>sub judice</u>, the Court finds that the appeal is not well taken. 
