This action came on for hearing on February 24, 1986 on Plaintiff's motion for default judgment filed with this Court on January 22, 1986. Defendants having failed to appear, the Court heard the merits of plaintiff's cause ex parte. The issues having been duly heard and a decision having been duly rendered,

It is ORDERED and ADJUDGED that:

- A) Defendant Turrill is permanently enjoined to comply with Order Nos. 84-02, 84-04, and 84-17 issued by the chief of the Division of Oil and Gas by plugging the Bostelman No. 1 well (Permit No. 122), the Okuley No. 1 well (Permit No. 123), the Faber No. 1 well (Permit No. 124), the Mahlman No. 1 well (Permit No. 125), the Crandall No. 1 well (Permit No. 3784) and the Baden No. 1 well (Permit No. 131), by no later than March 31, 1986.
- B) Defendant Pioneer Oil Company, Inc. is permanently enjoined to comply with Order No. 84-02 issued by the Chief of the Division of Oil and Gas by plugging the Baden No. 1 well (Permit No. 131) by no later than March 31, 1986.

- each assessed a civil penalty of one hundred thousand dollars for their failure to comply with the above-referenced orders and for their failure to prevent the escape of gas at the Baden No. 1, Bostelman No. 1, Okuley No. 1, Faber No. 1, and Mahlman No. 1 wells on and prior to July 2, 1985. Payment shall be made by delivering to the Fiscal Section, Division of Oil and Gas, Fountain Square, Building A, Columbus, Ohio 43224, a certified check in the stated amount made to the order of the "Treasurer, State of Ohio" by no later than March 31, 1986.
- D) Defendants Turrill and Pioneer Oil Company, Inc. shall pay the amount of one-hundred and seventy dollars to the Division of Oil and Gas for their failure to appear at a pre-trial held in this cause on January 9, 1986. Payment of this amount shall be made in the manner and form described in paragraph C above by no later than March 31, 1986.
 - E) Defendants shall pay court costs.
