JUDGMENT ENTRY

Upon application of the Plaintiff for judgment by default against Williston Oil Corporation and Joseph J.

Territo, and as a result of the failure of said Defendants to answer Plaintiff's interrogatories and furnish the requested documents filed with this court on March 21, 1983 and to comply with this court's order to compel discovery entered on September 12, 1983 against said Defendants, it is hereby ORDERED, ADJUDGED, and DECREED as follows:

I

Defendants Williston Oil Corporation and Joseph J.

Territo are permanently enjoined from placing or allowing
to be placed additional saltwater or other oil field wastes
in the pit located on the property of the Ohio Power Company
in Section 25, Blue Rock Township, Muskingum County, Ohio
(hereinafter "the pit"), and from creating, using, or maintaining other pits not constructed in an approved manner for
the storage or disposal of saltwater and other oil field wastes.

II

Defendants Williston Oil Corporation and Territo are permanently enjoined to lawfully dispose of the saltwater in the pit within three days after entry of this judgment,

and to fill the unlawful pit and grade and seed the disturbed area within thirty days after entry of this judgment.

III

Within thirty days after entry of this judgment, Defendants Williston Oil Corporation and Territo shall each pay a civil penalty in the amount of eight thousand dollars. Payment of penalties are to be by check made payable to the "Treasurer, State of Ohio" and forwarded to counsel for Plaintiff.

IV

Defendants Williston Oil Corporation and Territo shall pay court costs.
