

Ohio Bureau of Criminal Investigation CCU ANALYSIS REPORT





Summary:

On December 6, 2012, Special Agent John Saraya from the Ohio Bureau of Criminal Investigation received consent to search the contents of a mobile phone from Christopher Ereg. Said item was subsequently forwarded to BCI Cyber Crimes Unit Richfield, Ohio for analysis. This item is to be analyzed for evidence pertaining to the crime of Officer Involved Shooting regarding the subjects Timothy Russell and Malissa Williams.

Submitted Items:

EV15: EV15 is best described as an Apple manufactured mobile phone model iPhone A1349. The serial number associated with EV15 is . EV15 conforms to the Code Division Multiple Access (CDMA) standard. CDMA is one of two competing standards for mobile phones in the world. In addition to making and receiving phone calls, EV15 is capable of text messages, pictures, video, playing audio files, e-mail, browsing websites, and instant messaging. This phone also has approximately 16 GB (Gigabytes) of internal storage and it is not capable of additional storage.

Findings:

EV15: Attachment L contains seventeen (17) spreadsheets that detail information from EV15. These spreadsheets include: calendar events, calendar task, call history, contacts, device accounts, device app usage, device general information, device keyboard cache, device network information, locations history, locations searches, messages chat, messages status update, SMS (Short Message Service) messages, web bookmarks, web history, and web searches. It is necessary to note that calls and SMS messages that occurred between November 29, 2012 2200 hours and December 6, 2012 1715 hours are highlighted in yellow. Attachment M contains thirty-eight (38) calendar notes stored upon EV15. It is necessary to note that calendar notes 32 through 34 occurred between November 29, 2012 2200 hours and December 6, 2012 1715 hours. Attachment N contains one thousands three hundred thirteen (1,313) graphic files and seventy-three (73) video files stored upon EV15. It is necessary to note that two (2) of these images appear to depict scenes from the incident that occurred on November 29, 2012. These two (2) images and associated details are also appended for review as Attachment O. The Exchangeable Image File Format (EXIF) data embedded within these graphic images indicates that said images
