shootings for about the 15 years I've been here

at BCI.

As the lead, we have certain rules we follow. This is a criminal investigation, not internal. As such, our kind of rule, policy, is that this is criminal, you're entitled to all rights and privileges the same as everybody else. And you're going to be given your Miranda warnings.

As such, that doesn't mean we think you did anything wrong. It's just the way we do it.

THE WITNESS: Okay.

MR. SARAYA: Okay?

MR. GARDNER: My name is Scott Gardner.

I'm a detective/sergeant with the East Cleveland

Major Crimes Unit. I may have not spoken with

you, but I (inaudible).

THE WITNESS: Okay.

MR. SARAYA: We have a list of questions we're asking everybody here. At certain points we're going to let you carry on and ramble about what happened --

THE WITNESS: Okay.

MR. SARAYA: -- and how everything went down.

Please don't think the questions we ask you that we think you're stupid or anything.

We're going to ask the certain questions because we want you to expound on things. We're looking for the details and everything else.

Also, there are a couple of questions we ask and, yeah, they're kind of eye-rollers, we understand, but it's the important that we're asking everybody. Okay?

We're not singling you out because, "Oh, we think you did this" or anything else. Okay?

If at any time you have any questions for us, by all means, ask.

If there's something you want to share with them first, that's not a problem to say, "Can I talk to them?"

You guys can go out in the hallway, confer, and come back in.

THE WITNESS: Okay.



MR. GARDNER: Do you remember where you were?

THE WITNESS: Our exact location, no, I don't remember exactly where we were located as far as --

MR. GARDNER: Just approximately do you remember?

THE WITNESS: Probably Memphis-Fulton area, generally.

Zone 7, just to give you a background on our zone real quick, is a humongous zone. It

encompasses basically everything south of Denison that Cleveland owns between Brooklyn and Brooklyn Heights and the Parma boarder. It's a very large zone.

MR. KINAS: It's actually the largest zone in the City of Cleveland.

THE WITNESS: Yeah.

MR. KINAS: Larger than the City of Lakewood.

THE WITNESS: And that's the zone we patrol.

I mean, we could have almost been anywhere, but I think we would have been in that general area.

- A. This is the real deal. Because we get a lot of false calls. I'm sure you know how that goes.
 - Q. Uh-huh.
 - A. So we're thinking this is the real deal.

And we kind of stayed up in our zone still, because he said he was going to try to follow the vehicle.

I was kind of listening to his radio traffic. I don't remember word for word what he was saying, but I know he -- you know, he had it and he said it turned, like, left on Prospect I think, which would have been eastbound.

And then I know he lost it somewhere in the downtown area, and then it was picked back up by 2 Adam 31, which would have been Hummel and Siefer on the Detroit Superior Bridge.

That was a couple minutes past, I would say, from when Vic had broadcast that.

You know what I mean?

Q. Uh-huh.

A. Because I remember thinking, "How is it going to the Detroit Superior Bridge," because the way he said it we thought it would be going the other direction.

So he turned around somewhere and then went westbound instead of eastbound.

But -- so I know 2 Adam 31 tried to stop the vehicle. The vehicle refused to stop for them. You know, basically the chase was on.

So we were listening to the directions they were going, but we weren't heading down that way because I said, "Well, man, we'll just stay up here in case they come our direction."

So we actually started down westbound on Memphis heading towards Ridge at one point. I mean, we were listening to the whole thing going on.

You know, Randy's still just kind of driving, but we're staying closer to the, you know, Fulton, all that whole area, so we can get down there if we need to get down there.

Q. Okay.

A. Because they were pretty far away from us.

Zone 1, they had to have been in Zone 1, which is complete opposite district. We're all the way over here and they are all the way over here. That would have been, lights and sirens, a 12-minute trip.

A. So we just kind of hung in our zone listening to what directions they're heading.

When they started heading -- Clark -- they started heading eastbound on Clark at one point, and Randy turned around because we were by -- approaching Ridge.

Randy turned around on Memphis and went down Fulton towards Denison. The car continued eastbound and went down into the Steelyard area.

And so we were still kind of far behind from where they were at. And so I was telling Randy, I said, "Go to the freeway, like 176, in case they jump on the 176." And I said, "Go towards the freeway."

So he's driving towards the freeway, and I believe it was when they were at Steelyard when I first heard the mention of actually seeing a gun.

I want to say it was down in the Steelyard area is where Siefer had said, you know, "The passenger has a gun pointing a gun out the back window at us," you know, something to that effect.

And, you know, that's when it really hit. You're like, "Oh, my God, these guys really do have a gun."

You know what I mean?

You're like, "All right, this is getting even more serious now," because, you know, you're trying to process everything.

You figure you've got Vic calling in, then you've got the chase, and now you've got a gun pointed at other officers, so that really ups the level.

And, you know, a short time after that, they hit the freeway going eastbound on 90, and that's when Randy jumped on 176 northbound, because you can catch 90 East right from there.

And we were lagging pretty far back from -- I think we were way back, actually. But I had made a choice to grab the shotgun.

Q. Okay.

A. Because I said -- it was probably right around when we were getting on 90, I looked at Randy and I said," Randy, I'm getting the shotgun."

I said, "This could get bad quick."

I said, "If they're pointing a gun," I said, "if they wreck, they might be shooting or something."

I said, "I'm grabbing the shotgun."

It was actually kind of humorous. At one point I tried to put the shotgun back, because I was afraid if we got in an accident I've got a shotgun in my hand.

You know what I mean?

- Q. Yeah. You tried to put it back in the rack?
- A. I tried to put it back in the rack, but I couldn't because our pop bottles and stuff were in the way. It's true, I could not get that thing back in the rack. Randy's driving and you're moving all around, you know, so I just decided to hang on to it.

We remained on 90, 90 Eastbound. Like I said, we were so far -- we were pretty far back.

And they said they were getting off at 72nd, East 72nd Street, and we weren't at East 55th Street yet.

I told Randy, I said, "Get off at 55th in case they come back and want to jump back on the freeway the other direction."

Because that's like one exit apart -- one or two. Okay, it might be two.

But I remember they said, you know, they thought they were wrecking out. They were up in the grass or something on 72nd. I remember hearing something like that on the radio.

I'm not going to lie to you guys, I'm not going to remember every radio transmission.

- Q. That's fine. You remember whatever you can.
 - A. I'm trying to remember the best I can.
 - Q. You're doing fine.
- A. And -- but, as I said, they thought they were going to bail at East 72nd. We were already off at 55th at this point. We're like (inaudible) I'd say, I guess. But then the chase kept continuing southbound on 72nd.

Short time after that, you know, I know that a police car was rammed at some point. I don't know who it was. I heard that through the radio transmission, of a police car being rammed.

As this was going on, Randy and I were actually trying to figure out where we're at, because we didn't -- we don't really know the east side, that part of the east side, that well.

We both came from the Fourth District originally, but that's a long ways from where we were at.

But so he started going down some side streets as we're listening to the pursuit continue.

We actually -- I don't know who it was.

I think it was one of the districts, but we saw some zone cars flying past us.

So we're like, "Okay, we found it," you know. Then we jumped back in the line of pursuit.

My timeline may be a little bit off, but also, you know, during this time of all this going on, you know, somebody came across the radio, I don't know who it was, saying that they

saw them loading a gun.

You know, they're like, "They have a gun. They're loading a gun. It looks like they're loading a gun."

You know, trying to keep the timeline of all the radio chatter is tough.

But anyway, we're going through all these streets. I don't recognize these streets. I don't really know them that much. The main streets like Euclid and things like that I know, but these little side streets, I don't know them over there.

So we're going through all these streets. We're just kind of following the line of cars, police cars. End up going up this hill. They said they're going into the water treatment plant. And, like I said, we were kind of far back.

As we're going up the hill we hear over the radio somebody yelling, "Shots fired, shots fired," and we're like -- I mean, that's -- I mean, automatic you're thinking, "Holy crap, this is really happening," you know.

You're almost like, "I don't believe

this is really happening, " you know.

It's like, "These people are shooting at policemen now."

Because that's all the indications we've had some this whole time of pointing guns and everything else, this is what it's going to end up. I'm thinking to myself, "This is what's happening." It's someplace you don't really want to be, you know.

And so we come around the corner of -because you go up the hill and you make a right
into the lot. We were told it was a water
treatment plant, but it ended up being a school.

As we -- as we were turning, we saw these headlights coming at us. I want to say I heard somebody say, "Block it off," or something.

I think that was right around the time when they were yelling "Shots fired," they were saying, "Block it off," like block the driveway or something.

And -- but we go up, make our turn, we see these headlights coming right at us. This is the first time we actually saw the vehicle, that we actually physically saw the car.

And as Randy was driving towards it, the car ran into 238, whoever was driving 238. Ran into their car.

I mean, just bullets started. You could hear them. I mean, they were going everywhere.

And we're thinking -- or I'm thinking it's a major shootout at this point. I'm thinking there's two people shooting it out with however many policemen are right there.

Randy stops the car and I jump out and I saw the shotgun. I jump out. I run up next to 217.

And as I'm -- I see all these bullet holes in the window of 217 and that's when reality hit. I'm thinking, "Holy crap, this is really it."

I mean, my fear level just skyrocketed, because I'm like, "I'm in the middle of a shootout right now."

And I'm scared for my colleagues. I'm scared for myself. And, I mean, the adrenaline was just -- I'm sure my hands were probably shaking holding the shotgun.

And as I got by the window, I actually

could like feel -- it's hard to describe, but you could like feel the bullet going past you.

You know what I mean?
