WORKSHOP PROPOSAL

The Attorney General's 2024 Human Trafficking Summit, set to take place on Aug. 7 in Columbus, is accepting proposals for breakout sessions. We are excited to benefit from the knowledge and experience of so many others and are seeking interactive and innovative presentations that will engage summit attendees.

This year, the summit will focus on the vital role that an integrated system of care, known as a "continuum of care," plays in helping survivors achieve long-term healing on the "highway to hope." In recognition of the diverse backgrounds of summit attendees and feedback we have received, we are offering some workshop ideas for your consideration. Your topic needn't come from the list below, but you are welcome to submit one as your proposal. If you have your own idea, please submit it!

- Identifying restorative/rehabilitative services for survivors after leaving the life, such as job skills training, substance abuse recovery services, therapeutic services, community-based support, peer support, legal services, immigration assistance, healthcare, etc.
- Overcoming barriers in the criminal justice system with trauma-informed solutions that empower survivors and avoid revictimization
- Empowering the survivor voice, instilling survivor leadership and identifying employment opportunities
- Implementing/Strengthening a community continuum of care for survivors
- Highlighting a continuum of care and/or restorative and rehabilitative services through successful case studies
- Serving diverse populations and prioritizing cultural humility
- Exploring new research and best practices

All proposals must be complete and submitted according to the guidelines outlined on this form on or before March 31, 2024. Please email your proposals to HTI@OhioAGO.gov. A workshop submission does not guarantee a place on the program. The proposals will be evaluated by the Human Trafficking Initiative team; incomplete and unsigned proposals might not be considered.

Selected presenters agree to volunteer their time. Those chosen will be notified by April 12 and provided a code to have their summit registration fees waived. Presenters will be required to submit for review their entire presentation (outline, PowerPoints, etc.) by May 12, to ensure that the material covers current training philosophies and content.
