Dear Colleagues,
Under Ohio law, county sheriffs are responsible for issuing, denying, suspending, or revoking concealed carry licenses. On a quarterly basis, they report these statistics to the Ohio Peace Officer Training Commission, part of the Ohio Attorney General's Office. The commission then compiles those statistics annually for transmission to each of you no later than the first day of March, in accordance with Ohio Revised Code Section 109.731(C).

Since the implementation of Ohio's concealed handgun law in April 2004, the state has issued 296,588 regular and temporary concealed carry licenses. In 2011, county sheriffs issued 54,021 regular licenses (49,828 new licenses and 4,193 renewal licenses) and 73 temporary licenses.

## New Licenses Issued



Licenses Suspended


Under Ohio Revised Code (ORC) Section 2923.128, sheriffs must immediately suspend a concealed handgun license upon notification that the licensee has been arrested or charged with certain offenses or if the licensee is the subject of a protection order issued by a court. The license may be returned to the holder if he is found not guilty or the charges are dismissed.

It is important to note that some of these licenses may have been issued in previous years. Sheriffs are not required to report the details surrounding a suspension.

## Licenses Revoked



Also under ORC 2923.128, sheriffs must permanently revoke the license of any person who no longer meets the eligibility requirements to carry a concealed handgun.

There are several reasons that a license may be revoked. The license holder:

- Moved out of state
- Died
- Decided not to hold the license anymore
- Was convicted of a disqualifying crime
- Became subject to the law's restrictions on mentally ill people or people considered drugor alcohol-dependent

Sheriffs are not required to report the specific reason for the revocation to the Ohio Peace Officer Training Commission.

## Applications Denied



The law requires that sheriffs deny an application to any person who fails to meet the eligibility criteria specified in ORC 2923.125 for regular licenses or ORC 2923.1213 for temporary emergency licenses.

Licenses Renewed


The first renewal period under Ohio's concealed handgun law began in 2008 for those issued permits in 2004. Since then, 65,699 Ohioans have renewed their licenses. Currently, permit holders who wish to renew their licenses must do so every five years.

## Reciprocity Agreements

The law requires the Ohio Attorney General to craft reciprocity agreements with other states to allow Ohioans with Ohio permits to carry weapons in those jurisdictions and for those states' citizens to carry weapons in Ohio.

These agreements require an analysis of those other laws to ensure they meet the requirements of Ohio's concealed handgun law and vice versa (ORC 109.69).
