Dear Colleagues:
Through the Ohio Victims of Crime Compensation Fund, thousands of Ohioans who have been affected by violent crime are helped with and this year was no exception.

Ohio Revised Code (ORC) Section 2743.69 requires my office to prepare an annual update on the Ohio Victims of Crime Compensation Fund. This report, which covers the period from July 1, 2016 through June 30, 2017, fulfills that mandate and also details my office's other efforts to ease the burden crime victims face through no fault of their own.

Through the compensation fund, my office helps victims and their families recover certain costs incurred as a result of the crime, such as medical expenses, counseling, and lost wages. Since 1976, the compensation fund has distributed more than $\$ 365$ million to victims of violent crime in Ohio. During fiscal year 2017, my office processed 2,865 requests for compensation and paid out an average of $\$ 2,406$ per claim.

In 2017, Ohio became the second state in the country to create a network of Trauma Recovery Centers to help victims of violent crime. Five Trauma Recovery Centers - partnerships between victim service providers and five hospitals - will provide mental-health support and advocacy to patients who have fallen prey to violent crime, and will offer services such as substance-abuse treatment, specialized sexual assault or domestic violence counseling, legal advocacy, and spiritual guidance.

During fiscal year 2017, over $\$ 79.5$ million in grants were awarded to over 350 community agencies across Ohio. These grants ensure that victims have access to important, and in some cases, life-changing services. For example, a grant to OhioGuidestone helped re-establish the only domestic violence shelter in Carroll County and provided funding for a victim service provider. The Sexual Assault Response Network of Central Ohio received funding to operate its sexual violence helpline, which provides $24 / 7$ access to trained advocates for victims of sexual violence across the state.

In fiscal year 2017, the Crime Victim Services staff trained over 3,900 people on topics that included victim compensation, elder abuse, domestic violence, sexual assault, and child abuse. Our Two Days in May Conference on Victim Assistance - one of the largest gatherings of its kind in the nation - drew over 1,200 victim advocates and criminal justice professionals who took advantage of insightful presentations and useful workshops.

## Introduction

The Ohio Victims of Crime Compensation Fund was created in 1976 to help ease the financial impact inflicted on innocent victims of violent crime. Responsibility for the fund was transferred from the Court of Claims of Ohio to the Ohio Attorney General's Office on July 1, 2000. In addition to overseeing the compensation program, the Attorney General's Crime Victim Services Section administers state and federal grants to support communities' victim assistance programs and provides education and training for victims, victim advocates, and the general public.

## Grants Unit

The Grants Unit of the Crime Victim Services Section administers grants from the State Victims Assistance Act (SVAA) and the federal Victims of Crime Act (VOCA) which are made up of funds from court costs and fees, not taxpayer dollars. Recipients generally include domestic violence shelters, prosecutor-based victim/witness programs, child advocacy centers, and other similar governmental and nonprofit agencies that provide direct services to crime victims.

Due to an increase in VOCA funds, every Ohio county shared in more than $\$ 79.5$ million in grants distributed to over 350 organizations in fiscal year 2017. Some of the new programs being funded this year include:

- Network of Support Services: \$2.6 million - Five Trauma Recovery Centers, in partnership between victim services providers and five hospitals, will provide mentalhealth support and advocacy to patients who have fallen prey to violent crime. Ohio will be the second state in the nation with a network of Trauma Recovery Centers, which will offer services such as substance-abuse treatment, specialized sexual assault or domestic violence counseling, legal advocacy, and spiritual guidance.
- Helping Families in Need: \$4.8 million - A new pilot program announced in March 2017 to provide targeted treatment for troubled families. Ohio START (Sobriety, Treatment, and Reducing Trauma) offers specialized services - such as intensive trauma counseling - to children who have suffered victimization due to their parents' drug use and will operate in 19 counties (Adams, Athens, Brown, Clermont, Clinton, Fairfield, Fayette, Gallia, Highland, Hocking, Jackson, Lawrence, Meigs, Perry, Pickaway, Pike, Ross, Scioto and Vinton). The program, modeled on a successful effort in Kentucky, also provides drug treatment for parents of children referred to the program. Ohio START brings together child protective services, peer mentors, the courts, and behavioral health and treatment providers to work closely with families. Casey Family Programs, which partnered with the Attorney General's Office to develop the Ohio START program, is providing an additional \$75,000. Both grants are being administered by the Public Children Services Association of Ohio.

The unit also administers the Rape Crisis Fund which provided over \$1 million to rape crisis centers. The funding will be used to provide direct victim services, such as crisis response, hospital advocacy, and criminal justice advocacy to survivors of sexual assault statewide. In the current awarding period, programs are receiving $\$ 45,804$ each. The Ohio Alliance to End Sexual Violence was awarded $\$ 142,500$ to provide training and technical assistance to rape crisis centers throughout the state.

## Education and Policy Unit

The Education and Policy Unit provides training and technical assistance and also develops resources for victim services professionals. The unit also works to advance policies that secure rights and protections for victims. During fiscal year 2017, more than 3,900 individuals received some form of assistance from the unit including:

## Domestic Violence/Sexual Assault

Crime Victim Services offers training and technical assistance throughout the state on domestic violence, stalking, and sexual assault issues. Communities are seeking to improve their response to victims of violent crime and are creating better policies to collaborate with allied agencies.

In fiscal 2017, the section's DV/SA program provided trainings related to domestic violence, stalking, strangulation, elder abuse and sexual assault investigation and prosecution.

- Sixteen trainings were conducted in both rural and urban regions of the state.
- Over 700 multidisciplinary team members were trained by the Ohio Attorney General's Interpersonal Violence Response Training Team and national experts from the Strangulation Institute on Strangulation Prevention and International Association of Chiefs of Police. Courses included information on stalking, domestic violence, sexual assault investigation and prosecution, and strangulation.


## Sexual Assault Forensic Exam program

The Sexual Assault Forensic Exam (SAFE) program is statutorily mandated by ORC Section 2907.28 to cover medical expenses of patients examined after a sexual assault to ensure the proper collection of physical evidence for possible prosecution. The SAFE program reimbursed medical facilities for 7,152 exams at a cost of more than $\$ 4.3$ million in fiscal year 2017.

Nine communities in different regions of the state received training on the SAFE program and the importance of medical care, evidence collection, and patient rights. The training also provided insight into the work done by crime labs so health care providers understand the important role they have when listening and documenting the patient's assault history.

## Victim Information and Notification Everyday

The Victim Information and Notification Everyday (VINE) program helps crime victims and other concerned citizens gain access to information about the criminal cases and custody status of offenders. VINE provides information on the status of offenders within the Ohio Department of Rehabilitation and Correction (ODRC), the Ohio Department of Youth Services (DYS), and county jails. Individuals can register to be notified by phone, email, text, or TTY device when an offender's custody status changes. Users can register through their participating state toll-free number, VINEmobile smartphone app, VINEmobile Patrol app, or VINElink.com.

Recent VINE Service Enhancements for 2017 provided the following:

- VINE network upgrades with Jail Management Systems, which replaced VINE PCs with modems
- SMS Text Messaging Notification - implemented May 2017

Below are fiscal year 2017 VINE statistics:

- On average, 108,931 online searches were conducted each month at www.vinelink.com, the primary registration point for Ohio.
- On average, 5,757 new registrations are logged each month.
- VINELink usage increased 5.6 percent over comparable 12-month periods, from 824,564 to 871,308.
- New registrations increased 25.7 percent, from 54,932 to 69,084.
- Phone notifications increased 15.1 percent, from 302,998 to 348,719.
- E-mail notifications increased 22.6 percent, from 78,098 to 95,782.
- The VINEmobile application logged 81,686 site searches in the third full fiscal year of operation.

Child Victim trial preparation training
Sixty law enforcement officers, prosecutors, forensic interviewers, and child protection professionals were trained to interview and prepare children for court through Finding Words Ohio, an intensive five-day course that teaches professionals the necessary skills to conduct competent investigative interviews of child abuse victims.

## Support and Outreach Services

The Support and Outreach Services Unit provides direct victim advocacy and educates communities about available crime victim services. The unit coordinates training, special events and outreach activities by streamlining scheduling, providing registration and logistical support, and filing for continuing education credits.

The $26^{\text {th }}$ annual Two Days in May Conference on Victim Assistance was organized by the unit. The conference is one of the nation's largest conferences on victim assistance. Over 1,200 people attended the 2017 conference, themed A Call to Action. In addition, 48 victim advocates and criminal justice professionals were trained through the five-day Basic Advocacy Skills in Crime Victim Services (BASICS) Academy in fiscal year 2017.

After its initial contact with a victim of crime, the law enforcement agency responsible for investigating the crime must promptly provide the victim in writing an explanation of his or her rights, often in the form of the Ohio Crime Victim Rights Booklet, which is produced by the unit. In 2017, the section distributed 57,580 booklets to 360 agencies.

## Crime Victim Compensation Program

Chapter 2743 of the ORC governs the compensation program, which allows applicants to be reimbursed up to $\$ 50,000$ for economic losses they incur as a result of a violent crime. Economic losses that can be recovered are:

- Medical and related expenses
- Funeral and burial expenses (up to $\$ 7,500$ )
- Dependents' economic losses resulting from the death of a victim
- Counseling expenses for immediate family members of victims of domestic violence, sexual assault, homicide, or a crime that has resulted in a severe and permanent incapacitating injury, such as paraplegia (up to $\$ 2,500$ per family member)
- Crime scene cleanup expenses (up to $\$ 750$ )
- Compensation for property held as evidence (up to \$750)

Victims cannot receive compensation for pain and suffering or stolen property. Also, the program is a payer of last resort and will not compensate for economic losses that can be recovered from another source.

In order to participate in the program, the victim:

- Must not have engaged in any conduct that substantially contributed to the injuries sustained.
- Must not have engaged in violent felonious conduct or drug trafficking within 10 years of the incident for which the claim has been filed with this office.
- Must not have any felony convictions, domestic violence convictions, or child endangering convictions within 10 years of the incident for which the claim has been filed with this office.


## Administrative Costs

Administrative costs for fiscal year 2017 totaled $\$ 5,554,942$. The number of appeals to the Court of Claims decreased from 78 to 44.

The Attorney General's costs decreased 5.1 percent, from $\$ 5,854,969$ to $\$ 5,554,942$. Because this involved 5,430 claims, the Attorney General's cost per claim averaged \$1,023.

## Application and Award Summary

The Compensation Unit processed more than 5,430 compensation claims in fiscal year 2017. The average award for claims totaled $\$ 2,406$, up from $\$ 2,369$ the year before. The total amount paid to crime victims throughout the state was $\$ 6,893,297$ in fiscal year 2017. The unit's goal for the upcoming year is to make more people statewide aware of the compensation program and the assistance available.

The fund's balance has declined over the past 10 years, but has stabilized in recent years, as illustrated in the chart below. Fiscal year 2017 saw a decrease in the fund total of 11.5 percent.


## Attorney Fees

Two types of attorney fees are payable under the crime victim compensation statute.
Under ORC Section 2743.65, an applicant may seek the assistance of an attorney in filing for compensation or in appealing a decision of the Attorney General's Office. The \$124,036 in attorney fees paid out in fiscal year 2017 represents an 9.9 percent decrease from the previous year.

Under ORC Section 2743.51(F)(4), attorneys who assist the claimant with successfully obtaining a protection order or another order to physically separate the victim from the offender may receive reasonable attorney fees not exceeding $\$ 1,000$, at a rate not exceeding $\$ 100$ per hour. Attorney fees for reasonable travel time incurred to attend court hearings are paid at a rate not exceeding $\$ 30$ per hour. The total amount paid to attorneys assisting with protection orders decreased 3.7 percent in fiscal year 2017, from $\$ 419,201$ to $\$ 403,816$.

## Awards by Incident Type

As in past years, the majority of the awards paid went to victims of assault ( 50.2 percent). Next were awards related to incidents of sexual assault (12.7 percent) and domestic violence (10.2 percent).

## Subrogation

The Attorney General holds offenders financially accountable for their crimes. The Subrogation Unit's collection efforts against offenders, insurance companies, and other liable parties allow for the fund to be reimbursed. The chart below summarizes the results of the Subrogation Unit's efforts, which included returning \$322,462 to the fund in fiscal year 2017, an 18.1 percent decrease over the year before.
