Narrative:

On Saturday, August 5, 2023, at approximately 2112 hours, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Nick Valente responded to an officer-involved shooting which occurred at 205 US 250, Polk, Ohio. Prior to clearing the officer-involved shooting scene at 0155 hours on Sunday, August 6, 2023, SA Valente took possession of 28 items collected by BCI Crime Scene Unit personnel. These evidentiary items consisted of the involved deputies' pistols and tasers, three handguns found near the subject, a cellphone and baseball cap found near the subject, a magazine removed from the subject's shorts pocket, expelled taser blast doors, and cartridge casings. A receipt was completed for the evidence transfer.

SA Valente transported the evidence items to BCI and placed them into temporary evidence locker #1 at 0305 hours. The evidence receipt was updated and placed in temporary evidence locker #1 with the evidence items.
