The Ohio Attorney General's Office offers careers in law, criminal justice, science, and many other fields.

✓ Health Insurance

- Choice of medical plans
- Dental and vision coverage after one year of continuous employment

✓ Life Insurance

- Effective after one year of continuous employment
- Optional supplemental life insurance available

✓ Disability Benefits

- Effective after one year of continuous employment. Bargaining unit staff members receive the equivalent of 70 percent of their salary for six months and 50 percent of their salary for the next six months. Lifetime maximums vary.
- Exempt employees receive the equivalent of 70 percent of their salary for three months and 50 percent of their salary for the next nine months. The lifetime maximum is one year.

✓ Ohio Public Employees Retirement System

- The office contributes 14 percent of employees' gross wages to the retirement plan.
- Employees contribute 10 percent of their gross wages to the plan.

The Ohio Attorney General's Office offers careers in law, criminal justice, science, and many other fields.

✓ Health Insurance

- Choice of medical plans
- Dental and vision coverage after one year of continuous employment

✓ Life Insurance

- Effective after one year of continuous employment
- Optional supplemental life insurance available

✓ Disability Benefits

- Effective after one year of continuous employment. Bargaining unit staff members receive the equivalent of 70 percent of their salary for six months and 50 percent of their salary for the next six months. Lifetime maximums vary.
- Exempt employees receive the equivalent of 70 percent of their salary for three months and 50 percent of their salary for the next nine months. The lifetime maximum is one year.

✓ Ohio Public Employees Retirement System

- The office contributes 14 percent of employees' gross wages to the retirement plan.
- Employees contribute 10 percent of their gross wages to the plan.

✓ **Sick Leave**

- Accrues at 3.1 hours for each 80 hours worked. (excluding overtime)

✓ **Holidays**

- 10 paid holidays per year

✓ **Vacation Leave**

- Employees are eligible immediately after completion of a probationary period, if applicable. The accrual rates vary depending on years of qualified service and bargaining unit/exempt status.

✓ **Bereavement Leave**

- Three consecutive work days upon the death of an immediate family member

✓ **Optional Benefits**

- Deferred compensation program
- Employee credit union
- Flexible spending account program for health and dependent care expenses
