Narrative:

On Thursday, October 5, 2022, Ohio Bureau of Criminal Investigation (BCI) Special Agent (SA) Matthew Armstrong (Armstrong) and BCI SA Charles Snyder (Snyder) conducted a neighborhood canvass in the area of 2347 East Waterloo Road, Akron, Ohio. The purpose of the canvass was to identify and interview potential witnesses to the officer-involved shooting that occurred on October 5, 2022, in the backyard of 2347 East Waterloo Road, Akron, Ohio. Each of the interviews was audio recorded and attached to this report. During the neighborhood canvass, agents spoke with the individuals at the following addresses:

1046 Mohawk Trail

Resident Andrea Dalton (Andrea) reported no one was home when the incident occurred. She did have a Wyze surveillance camera mounted on the back (north side) of her residence. She reported it recorded audio and video footage when the incident occurred. Andrea was unable to provide agents with a copy of the footage; and in an attempt to cooperate, removed a 32 GB memory card from the back of the Wyze camera. SA Snyder completed a consent to search form and Andrea turned the memory card over to SA Armstrong, who was able to locate and obtain a copy of the relevant recordings captured by the camera. Andrea was provided a receipt for property and the memory card was returned to her by SA Snyder on October 26, 2022. A copy of the property receipt and the consent to search form has been attached to this report.

2305 E. Waterloo Rd., Lot 31

Resident Donna Storey (Donna) reported she was home at the time of the shooting. Just before 10:00 AM, she heard two revolvers or small caliber shots go off. After that, she heard about five to seven larger caliber shots go off. After that, it got quiet for a couple minutes, then she heard sirens. Donna reported she did not see any portion of the shooting and she did not hear any yelling. When she looked out the window, she saw all the police cars there. She clarified that the first two gunshots were a fast "pop pop," then the others were a second or two apart. She estimated a few seconds elapsed between the two sets of gunshots. She did not have video recordings of the incident. She did not know any of the people involved in the shooting.

James was at the table in his trailer, when he heard, "pop, pop, pop, pop, pop." They had a camera on the back of their trailer which points in the direction of where the incident occurred, but it was not set up to record.
