### Narrative:


On July 7, 2023, Ohio Bureau of Criminal Investigation (BCI) Special Agent Dave Hornyak delivered a search warrant to the Miami Valley Hospital ordering the release of Dione Kellum's medical records related to his treatment directly following an Officer-Involved Critical Incident that occurred in Lebanon, Ohio, in June 2023.

On July 24, 2023, the medical records were received and reviewed.
