FINDINGS OF FACT

- 1. On October 16, 2007, the Director of the Ohio EPA ("Director") issued a Proposed Order proposing to deny A & L Salvage's application for a 2007 Construction and Demolition Debris (C&DD) license for the A & L Salvage Landfill Facility located on State Route 45, Lisbon, Ohio ("Facility").
- 2. On November 9, 2007, A & L Salvage filed a Request for Adjudication Hearing objecting to the Director's proposed denial of A & L Salvage's application for a 2007 C&DD license for the Facility.
- 3. On February 10, 2011, this Hearing Officer issued a "Notice of Intent to Issue Report and Recommendation Recommending Dismissal."
- 4. My February 10, 2011 "Notice of Intent to Issue Report and Recommendation Recommending Dismissal" states in pertinent part: "It is my understanding that the A & L Salvage Landfill has been closed. Consequently, it is my understanding that the question of the issuance of a license to operate the A & L Salvage construction and demolition debris landfill is moot. Based upon the fact that the question of the issuance of a license to operate is moot, it is my conclusion that this case is moot and should be dismissed."
- 5. No response or objection to my February 10, 2011 "Notice of Intent to Issue Report and Recommendation Recommending Dismissal" has been filed.
- 6. No adjudication hearing has been held in this matter.

CONCLUSION OF LAW

1. Given the fact that the A & L Salvage Facility is closed, there remain no unresolved issues of law or fact requiring an adjudication hearing in this matter. Therefore, Ohio EPA Case No. 07-CD-011 is most and should be dismissed.
