 Plaintiff's motion to consolidate hearings on its request for preliminary and permanent injunctive relief is granted; and further

2. Upon stipulation of the parties Defendants Boyle Coal Company and Leo J. Boyle as president of Boyle Coal Company have engaged in a coal mining operation without a permit in violation of R.C. §§1513.17(A) and 1513.16(A)(20) on an area of land adjacent to Boyle Coal Company permit no. C-1031 located in Ward Township, Hocking County, Ohio; and further

3. Defendants, their agents, employees, contractors or any acting by or on behalf of Defendants are PERMANENTLY ENJOINED from conducting any coal mining operations on the unpermitted, unbonded areas outside the permit limits of Boyle Coal Company permit no. C-1031 until such time as Defendants submit a complete application for a D permit, post the required bond and acreage fees and obtain a D permit from the Chief of the Division of Reclamation for any and all areas already so affected and any
