JUDGMENT ENTRY

Upon consideration of the State's Complaint, which Defendant Ronald D. Durbin ("Defendant Durbin") failed to answer or otherwise file a responsive pleading, and the State's Exhibits and testimony presented at the Default Hearing held on February 20, 2015, this Court grants the State's Motion for Default Judgment and issues the following orders:

A. Defendant Durbin is permanently enjoined from violating R.C. Chapter 3737 and the rules promulgated and adopted thereunder, and any Orders issued by the State Fire Marshal.

B. Defendant Durbin and his agents, representatives, employees, successors, or assigns, under the names that they presently use or any other names they use through any corporate or other device, and those acting in concert and participation with the Defendant directly or indirectly, are permanently enjoined from engaging in the acts or practices of which the State complains.

C. Pursuant to R.C. 3737.882(C)(2), Defendant Durbin is ordered to pay a Fifty Thousand Dollars (\$50,000) civil penalty for the violations described in Counts One through


Three of the State's Complaint. This civil penalty shall be made by delivering to the State, c/o Scott Hainer, Paralegal, or his successor at the Office of the Attorney General of Ohio, Environmental Enforcement Section, 30 East Broad Street, 25th Floor, Columbus, Ohio 43215, a cashier's or certified check or a money order, payable to the order of "Treasurer, State of Ohio."

D. Defendant Durbin is ordered to pay the unpaid registration fees for the UST systems at the Property for program years 1992 through 2013 in the amount of Six Thousand, Five Hundred Ten Dollars (\$6,510). This payment shall be made in the same manner as set forth in Paragraph C.

E. Defendant Durbin is ordered pay all the costs of this action.

F. This Court shall retain jurisdiction of this suit for the purpose of making any order or decree the Court may deem necessary at any time to enforce and administer Defendant Durbin's compliance with, and to carry out, this Court's judgment.
