CONSENT JUDGMENT

The complaint having been filed in the above-referenced case on July 1, 1985, and plaintiff State of Ohio and Defendants H. & D. Drilling Co., Inc. and Harold Donaker having consented to this Consent Decree without findings of fact or conclusions of law.

NOW, THEREFORE, upon the pleadings, and upon consent of the above-stated parties, it is ORDERED, ADJUDGED, AND DECREED as follows:

I

This Court has jurisdiction over the parties consenting to this Decree, and over the subject matter of the action. The complaint states a claim upon which relief may be granted under Chapter 1509, Revised Code.

II

This Consent Judgment applies to Defendants Harold Donaker and H. & D. Drilling Company, Inc., their agents, employees, and successors, and to all persons, firms, corporations, and other entities having notice of the Judgment and acting in privity with defendants.

Defendants are permanently enjoined from disposing of brine and other oil field wastes in a manner other than that approved by the chief pursuant to R.C. 1509.22 on the Leiton and Blanche Nelson lease, Sections 14 and 15, Fallsbury Township, Licking County, Ohio and the Thelma B. Sharp lease, Section 16, Fallsbury Township, Licking County, Ohio.

IV

Defendants are hereby ORDERED to pay a civil penalty of \$10,000. Payment shall be made either within thirty days after entry of this judgment or in four quarterly installments at an annual interest rate of 10%, or two thousand, six hundred and fifty-eight dollars and eighteen cents (\$2,658.18) every three months (30 days) after entry of this order. Payments shall be made by delivering to the Fiscal Section, Division of Oil and Gas, Fountain Square, Building A., Columbus, Ohio 43224, a certified check in that amount made to the order of "Treasurer, State of Ohio".

V

Defendants shall pay court costs.
