## LYNCH, J.

This matter is before the Court upon the motion of Appellee, Director, Ohio Department of Job and Family Services ("ODJFS") to dismiss the within action for failure of Appellant, Timothy Sweatte ("Appellant") to prosecute this matter, filed on May 4, 2016 (the "motion to dismiss".) In response to the motion to dismiss, Appellant filed a "Motion to file a continous" [sic] in which he indicated that he was aware of the motion to dismiss filed by ODJFS and he needed "to find out the reason" it was filed. The Court then issued its June 7, 2016 Order Holding in Abeyance Motion of Appellee to Dismiss; Entry Granting Motion of Appellant for Continuance; and Notice of Intent to Dismiss for Failure to Prosecute (the "June 7, 2016 Entry"), which afforded Appellant twenty-one days from the date of the aforementioned entry in which to file his brief.

More than twenty-one days have passed since the issuance of the June 7, 2016 Entry and Appellant has failed to file his brief. Accordingly, the motion of

ODJFS to dismiss for failure to prosecute is hereby **GRANTED**, and pursuant to Civ.R. 41(B)(1), the within matter is hereby **DISMISSED**, with **prejudice**.
