FIRST COUNT- AS TO CHAD T. GATTER

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for Lucas County, Ohio, on their oaths, in the name and by the authority of the State of Ohio, do find and present that CHAD T. GATTER, as a course of conduct beginning on or between the 22ND day of JUNE, 2022 and continuing through the 31ST day of AUGUST, 2022, in Lucas County, Ohio, did, knowingly transport more than ten (10) scrap tires in a single load somewhere in this state without first registering with and obtaining a registration certificate from the director of environmental protection, in violation of §3734.83(A) and §3734.99(F) OF THE OHIO REVISED CODE, ILLEGAL TRANSPORTATION OF SCRAP TIRES, BEING AN UNCLASSIFIED FELONY, contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

SECOND COUNT-AS TO CHAD T. GATTER

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for Lucas County, Ohio, on their oaths, in the name and by the authority of the State of Ohio, do find and present that CHAD T. GATTER, as a course of conduct beginning on or between the 22ND day of JUNE, 2022 and continuing through the 31ST day of AUGUST, 2022, in Lucas County, Ohio, did, recklessly dispose of solid waste by open dumping and the offense involved scrap tires, in violation of §3734.03 and §3734.99(A) OF THE OHIO REVISED CODE, OPEN DUMPING OF

SCRAP TIRES, BEING AN UNCLASSIFIED FELONY, contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

THIRD COUNT-AS TO AMANDA N. WAGNER

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for Lucas County, Ohio, on their oaths, in the name and by the authority of the State of Ohio, do find and present that AMANDA N. WAGNER, as a course of conduct beginning on or between the 22ND day of JUNE, 2022 and continuing through the 31ST day of AUGUST, 2022, in Lucas County, Ohio, did, act with the kind of culpability required for the commission of an offense, and did aid or abet another in committing the offense of illegal transportation of scrap tires, an unclassified felony, namely, at multiple tire store generators, assist Chad T. Gatter in the loading and placement of scrap tires in vehicles wherein the said Chad T. Gatter did, knowingly transport more than ten (10) scrap tires in a single load somewhere in this state without first registering with and obtaining a registration certificate from the director of environmental protection in violation, of §2923.03(A)(2) and §3734.83(A) and §3734.99(F) OF THE OHIO REVISED CODE, COMPLICITY IN THE COMMISSION OF ILLEGAL TRANSPORTATION OF SCRAP TIRES, BEING AN UNCLASSIFIED FELONY, contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.

FOURTH COUNT-AS TO AMANDA N. WAGNER

THE JURORS OF THE GRAND JURY of the State of Ohio, within and for Lucas County, Ohio, on their oaths, in the name and by the authority of the State of Ohio, do find and present that **AMANDA N. WAGNER**, as a course of conduct beginning on or between the 22ND day of JUNE, 2022 and continuing through the 31ST day of AUGUST, 2022, in Lucas County, Ohio, did, recklessly dispose of solid waste by open dumping and the offense involved scrap tires, in

violation of §3734.03 and §3734.99(A) OF THE OHIO REVISED CODE, OPEN DUMPING OF SCRAP TIRES, BEING AN UNCLASSIFIED FELONY, contrary to the form of the statute in such case made and provided, and against the peace and dignity of the State of Ohio.
