On this date, Detective Sergeant Scott Gardner, with the East Cleveland Police Department was asked to review and summarize a secondary personnel file that was given from the Cleveland Police Department relative to this investigation. Below is a summary of secondary personnel file given.

Appointment:

It is shown that William Salupo was appointed to Cleveland Police Department on October 23, 1995 but there are other records giving the date of February 17, 1998. Salupo held the position of Cleveland Institutional Guard until he was hired as a police officer on February 17, 1998.

Commendations:

No letters of commendations are present in Officer Salupo's.

Discipline:

March 6, 2000 Salupo received a verbal reprimand for "Officer to operate a police vehicle in a careful and lawful manner".

There is also a letter of "Re-Instruction" dated March 28, 2008. The letter stated that corrective measure would be counseling relative to a January 25, 2008 incident where Officer Salupo "did not operate a police vehicle carefully".
