INCIDENT CLEVELAND POLICE DEPARTMENT PURSUIT/SHOOTING 11/29/2012

On January 18, 2013, while assigned to Special Investigation in cooperation with the Ohio Bureau of Criminal Investigation and Identification (BCII) and the East Cleveland Police Department (ECPD). Detective Sergeant Jim Ruth and I Detective Sergeant Clifford E. Pinkney were assigned to interview Cleveland Police Department (CPD) Sergeant Matthew Gallagher in the presence of CPD Union representatives Lt. Brian Bentley and Jerry Zarlenga. Also present was Union Attorney Robert Phillips. The Interview took place at 4055 Highlander parkway, Richfield, Ohio 44286.

DETAILS

Sgt. Gallagher said he was back at the district when he heard Sgt. Shepard call out the pursuit, Sgt. Gallagher said he believes it was after 10:00pm. Sgt. Gallagher said the pursuit left his district and he switched his radio over to channel 2 to hear what was going on. Sgt. Gallagher said the pursuit was headed west so he loaded his equipment and headed out on the road in his vehicle. According to Sgt. Gallagher the pursuit went far west then headed back eastbound towards his district. Sgt. Gallagher stated that he never got personally involved in the pursuit he just blocked off intersections for the pursuing vehicles. Sgt. Gallagher said he did see the suspect vehicle pass by around the area of East 71st and Wade Park. Sgt. Gallagher said the pursuit left the city of Cleveland headed towards the city of East Cleveland and he never left the city or his sector. Sgt. Gallagher stated that he heard over the radio shots fired and the transmissions of the officers calling for EMS at the end of the pursuit at Heritage School.

Sgt. Gallagher said he slowly made his way to Heritage school to see if he could be of any assistance at the scene. Sgt. Gallagher said when he arrived at the scene he believes that he parked on Lee road across from Heritage school. At the crime scene Sgt. Gallagher saw his Lieutenant and was instructed to help put up crime scene tape. Sgt. Gallagher said he noticed a 2nd district officer with a cut on his forehead at the crime scene but he did not know the officers name. Sgt. Gallagher said none of his officers were involved in the shooting and he was at the

crime scene only twenty (20) minutes. Sgt. Gallagher said after the crime scene was secured, he and his officers returned to the 3rd district to answer calls and perform their duties. Sgt. Gallagher said when he was leaving the crime scene the East Cleveland Police Department (ECPD) had arrived and was starting to take over the crime scene. Sgt. Gallagher said he believes that his actions and the actions of the other officers were consistent with the training. Sgt. Gallagher said he heard over the radio Sgt. Mark Shepard from the 3rd district terminate the pursuit. Sgt. Gallagher went on to say that he never exercised any supervisor authority over the pursuit and he never left his sector until the pursuit ended in East Cleveland at the Heritage school.
