12/05/12 - Police Reports Obtained from Mentor, Willowick, and Willoughby PDs

Summary

On December 5, 2012, S/A Patricia Stipek obtained police reports from Mentor, Willoughby and Willowick Police Departments regarding a police chase on December 3, 2011.

Details

On December 5, 2012, S/A Patricia Stipek went to Mentor Police Department regarding the police chase on December 3, 2011 involving Timothy R. Russell. The police dispatcher gave S/A Stipek a packet of information. S/A Stipek asked to speak with one of the Detectives regarding this incident. S/A Stipek was directed to Det. Jim Collier who stated that Mentor's involvement is documented in the reports that S/A Stipek now had in her possession. Det. Collier commented that Willowick and Willoughby PD would be the other departments involved in this 2011 police chase. Det. Collier stated that the Willowick Police case number is 11-12605. Det. Collier stated that there was a dash camera video taken by the Willowick Police Department.

S/A Stipek went to the Willowick Police Department and spoke to Det. John Malady. Det. Malady handed S/A Stipek a packet containing information about this chase on December 3, 2011. Included in this packet was a CD marked "Unit 835, 12/3/11, Ptl. Guerrieri".

S/A Stipek went to the Willoughby Police Department and spoke to Det. George Lessick regarding this police chase. Det. Lessick stated that the only involvement that Willoughby Police had was that they attempted "stop sticks" without success. Their case number was 1126512.
