12/06/12 INTERVIEW ATTEMPTS WITH POSSIBLE RELATIVES OF RUSSELL

Summary

On December 6, 2012 at 1334 hrs, Sergeant Donald Cleland of Cuyahoga County Sheriff's Office and S/A Jean-Philippe Rigaud attempted contact with subjects who were possibly related to deceased Timothy R. Russell. Sgt. Cleland and S/A Rigaud did make contact with Michelle D. Russell at her residence of 19115 Fairway Avenue, Maple Heights OH 44137. The purpose of the contact was to speak with Michelle Russell regarding case SI-18-12-82-1493.

Details

On December 6, 2012 at 1334 hrs, Sergeant Donald Cleland of Cuyahoga County Sheriff's Office and S/A Jean-Philippe Rigaud attempted contact with subjects who were possibly related to decedent Timothy R. Russell. Sgt. Cleland and S/A Rigaud did made contact with Michelle D. Russell at her residence of 19115 Fairway Avenue, Maple Heights OH 44137. The purpose of the contact was to speak with Michelle Russell regarding case SI-18-12-82-1493.

Sgt. Cleland and S/A Rigaud arrived at 19115 Fairway Avenue, Maple Heights, Ohio 44137. Sgt. Cleland knocked at the side/driveway doorway to the residence and a black female opened the door. Sgt. Cleland asked her if she was Michelle Russell and she stated that she was. Sgt. Cleland asked if she would be willing to speak with investigators regarding Timothy Russell. Michelle Russell stated that it was not a good time. Sgt. Cleland provided Russell a business card and asked her to contact him when she was able. Russell stated she would call him.

As Sgt. Cleland and S/A Rigaud drove away, S/A Rigaud observed a gray Mitsubishi SUV with Ohio license plate EAU 8865 parked in the driveway of 19115 Fairway Avenue, Maple Heights OH 44137. S/A Rigaud subsequently confirmed that the owner of this vehicle was Michelle Russell.

Sgt. Cleland and S/A Rigaud attempted contact with two (2) other possible relatives with no success.
