12/06/2012 INTERVIEW OF STEPHANIE DANIEL, R-CAP SECURITY

Summary

Pursuant to the ongoing Cleveland Police Department officer involved shooting of Timothy Russell and Malissa Williams on November 29, 2012, Ohio Bureau of Criminal Investigation Special Agents Kevin Cooper and Perry Roeser interviewed Stephanie Daniel, Security Guard for R-Cap Security. The interview took place on December 6, 2012 at 1600 hours at the security guard area of Turner Construction Area, located at the security booth at the intersection of West Third Street and Lakeside Avenue. A copy of the security detail of Daniel was obtained and is attached to this investigative report.

Details

Pursuant to the ongoing Cleveland Police Department officer involved shooting of Timothy Russell and Malissa Williams on November 29, 2012, Ohio Bureau of Criminal Investigation Special Agents Kevin Cooper and Perry Roeser interviewed Stephanie Daniel, Security Guard for R-Cap Security. The interview took place on December 6, 2012 at 1600 hours at the security guard area of Turner Construction Area, located at the security booth at the intersection of West Third Street and Lakeside Avenue. A copy of the security detail of Daniel was obtained and is attached to this investigative report.

Daniel was questioned concerning her security detail of the late evening of November 29, 2012. Daniel provided the following statements:

Daniel stated she works for R-Cap Security, which is sub-contracted through TMG Services for security personnel.

Daniel stated she had no knowledge of the officer involved shooting of November 29, 2012.

Daniel stated she began her security detail at 1500 hours on Thursday, November 29, 2012.

Daniel stated her shift ended at 2300 hours on November 29, 2012.

Daniel stated she began a security walk at 2145 hours. Daniel stated she uses a detex wand at four points located around the construction area, which is within the block of West Third, Ontario, St. Clair and Lakeside Avenue. Daniel stated the detail requires she walk directly in front of the Cleveland City Justice Center, located at 1200 Ontario Street, Cleveland, Ohio 44113.

Daniel stated after completing her security walk, she crossed Lakeside Avenue and began walking back to her booth. Daniel stated she took a route along a sidewalk from Lakeside Ave. to a stairway entrance leading to a lower area where the security booth is located. Daniel stated she was approximately one hundred (100) to one hundred fifty (150) yards north of Lakeside Avenue along the aforementioned sidewalk, when she heard a loud shot-like sound, followed by a brief pause, followed by two additional shot-like sounds. Daniel stated she stopped and looked back towards Lakeside Avenue to see what was causing the sound. Daniel stated she stood and watched but didn't see any vehicles. Daniel stated she didn't see anything and continued down the stairs to the security booth. Daniel stated she estimated the time of the shot-like sounds at 2215 hours. Daniel stated she may be off on the times.

Daniel stated she was off-duty at 2300 hours.

A copy of the security detail of Daniel was obtained and is attached to this investigative report.
