NEIGHBORHOOD CHECK

Summary

On December 6, 2012, S/A Thomas Verhiley and S/A Patricia Stipek conducted a neighborhood check in the vicinity of Heritage Middle School, East Cleveland, Ohio.

Details

On December 6, 2012, at approximately 11:30 hours, S/A Thomas Verhiley and S/A Patricia Stipek went to Heritage Middle School, 14410 Terrace Road, East Cleveland, Ohio 44112. S/A Verhiley and S/A Stipek briefly spoke to Mr. Calvin Clark, Guidance Counselor, regarding personnel working at the time of the Cleveland Police Department incident. Mr. Clark stated that the principal, Mr. Kamal Chatman, would be the person to speak with regarding personnel. Mr. Clark took S/A Verhiley's and S/A Stipek's business cards and stated that he would forward them to Mr. Chatman.

As S/A Verhiley and S/A Stipek were leaving Heritage Middle School, Mr. Chatman was walking down the hallway, about to leave. S/A Verhiley told Mr. Chatman that we needed just a couple minutes of his time. Mr. Chatman took S/A Verhiley and S/A Stipek into his office. S/A Verhiley asked Mr. Chatman about any personnel working at the time of the Cleveland Police Department incident. Mr. Chatman stated that there was not anyone working at this time and that any questions regarding this incident are to be referred to Mrs. Myrna Corley, Superintendent (216) 268-6576. S/A Verhiley asked about video footage of the parking lot. Again, Mr. Chatman believed there was some footage, but that this would have to go through Mrs. Corley. Mr. Chatman was scheduled to meet Mrs. Corley in twenty minutes and would forward her S/A Verhiley's and S/A Stipek's business cards.

S/A Verhiley and S/A Stipek began a neighborhood check of the surrounding homes. The following information was gathered:

TERRACE ROAD

14303 – Empty

14309/14311 – J. Paradise on mailbox – no one home

14435 – Black male, tall, dread locks stated that he heard shots; went outside and saw a lot of cruisers.

14436, 14502 – No one home

14507 - Christan Stephens - heard gunshots

14508 – No one home

14511 – Terri A. Tolefree saw a lot of cop cars – looked like a "Christmas tree"

14515 - Older black female heard shots fired

14519, 14520, 14524, 14525 – No one home

14528 – Older black female didn't see anything

14529, 14533, 14600, 14606, 14609, 14620 – No one home

ROSEMONT ROAD

1907 – Young black male and older female – knew nothing

1915 – No one home

1918 – James Sanders – Police came down street (6-7 of them); Cleveland and unmarked cruisers; didn't know who they were looking for; heard the shooting then smelled gunshot residue

1922 - Charlotte Brooks - sounded like firecrackers; didn't know what it was

1931 - No one home

1934 – Barbara Jones – 25 or so police; blocked off Terrace Road

PRIVATE DRIVE

14900 – McGregor Nursing Home – S/A Verhiley and S/A Stipek spoke with Darlene Rumienski. Ms. Rumienski did not believe that there were any people who saw the incident. Ms. Rumienski did state that there were personnel coming in at 11:00 pm to work that evening. S/A Verhiley gave Ms. Rumienski a business card and told her to forward it to her supervisor.
