12/07/2012 REVIEW OF CUYAHOGA COUNTY SHERIFF'S DEPARTMENT AUDIO CD AND RADIO CALL LIST

Summary

On December 6, 2012, an audio CD and a radio call list had been turned over by Cuyahoga County Sheriff's Department Sergeant Cliff Pinkney to S/A Mark Kollar at the BCI Richfield Office, 4055 Highlander Parkway, Richfield, Ohio, 44286. The CD and radio call list contained Cuyahoga County Sherriff's Department radio communications from November 29, 2012. On December 7, 2012, S/A Jean-Philippe Rigaud reviewed the CD and radio call list to prepare a summary of critical radio traffic for case SI-18-12-82-1493.

Details
