**12/08/2012 REVIEW VIDEO OF WILLIAMS' PRIOR ARREST**

**Summary**

On Tuesday, December 8, 2012 Special Agent Eric Lehnhart reviewed a video submitted by the Cleveland Police Department.

**Details**

Special Agent Eric Lehnhart received from Special Agent Mark Kollar a purple compact disc holder with a yellow sticky note that read, "Video of Malissa Previous Arrest." Kollar asked that the video contained on the disc be viewed and summarized.

Contained inside the purple compact disc holder was one (1) silver Memorex DVD+R. This is a readable 16x 4.7GB 120 mm disc. The file located on the disc was titled "East Cleveland Evidence.MOV and was created on December 7, 2012 at 12:01 AM. File size was 171 MB (180,200,815 bytes) 175,978 KB. The video file contained on the disc is 00:06:49 in length.

The video depicts two black males and one black female. The two males are dressed in plain clothing and appear to be operating a public safety vehicle. The female is also wearing plain clothes (orange shirt with white horizontal strips, orange billed hat, blue jeans) and is restrained by wrist restraints in the back driver's side seat.

- 00:04 Male voice: <beep> "from here, one female under for warrants. Show us in route to CPU with this female starting mileage is 504.
- 00:16 Female voice: "that's all you do, gonna lock someone up, you're a nigger bitch and your friend is too. A nigger bitch and you can write it up."
- 00:27 Female voice: "I don't give a fuck about Miss Carver's...Pauline's dead ass. Period point blank, dude. You can put it on there...you can show it on there. I don't give a fuck, I will kill you. I don't give a fuck what you talking about. I will kill that dead old bitch. Period, crack head, dick sucking mouth ass ho. I don't give a fuck about that pussy motherfucker. Dick motherfucker ass ho. Pauline bitch outta here old on her period, period dude."
- 00:56 Vehicle driving, female quiet.
