## 12/19/2012 EXAMINATION OF RTA CAMERA AT WINDERMERE-29

## **Summary**

On December 19, 2012, Special Agent Mark Kollar assigned Special Agent David Pauly to review RTA Camera video titled Windermere-29. The collected DVD was reviewed by Special Agent David Pauly for the purpose of submitting a summary of events for the Cleveland Police Department officer involved shooting on November 29, 2012.

## **Details**

On December 19, 2012, Special Agent David Pauly was requested to review the DVD and summarize its content. The following information was gathered from the DVD:

- The video first depicts a view of eastbound Euclid Avenue. On the south side of Euclid Avenue, Windermere and Knowles Streets intersect. East of Knowles Street, also to the south of Euclid Avenue, is the Beersford Avenue intersection. Further east, intersecting from the north, is Stokes Windermere Street. The time depicted on the camera video indicates 10:48:21 pm.
- Starting at 10:48:41 pm, six vehicles stop in the two eastbound lanes (stacked three and three) of Euclid Avenue, at the light between Knowles and Beersford Avenue.
- At 10:49:38 pm, the first police vehicle, an unmarked dark vehicle with lights flashing, is depicted traveling eastbound on Euclid Avenue, in the turn lane, just north of the six stopped vehicles.

- Just after the first unmarked police vehicle enters the video, the subject vehicle, along with several other marked police cruisers enter the video. The subject vehicle appears to turn southbound into a drive, between Knowles Street and Beersford Avenue. The subject vehicle then turns onto Beersford Avenue and back onto Euclid Avenue, driving eastbound.
- Police cruisers, both marked and unmarked, continued the pursuit eastbound on Euclid Avenue, following the subject vehicle. It appears that seven police cruisers followed the subject vehicle onto Beersford Avenue and then turned back eastbound onto Euclid continuing to follow the subject vehicle.
- The video depicts the first police vehicle entering the video at 10:49:38 pm. The last police vehicle through the intersection, traveling eastbound on Euclid Avenue was depicted on the video at 10:59:37 pm.
- S/A Pauly counted six (6) unmarked vehicles involved in the pursuit and fifty-five (55) marked vehicles involved in the pursuit.
- Due to the lack of light, the flashing of the lights, it was difficult to identify from what law enforcement agency each police cruiser was.

Special Agent Pauly concluded the review of the RTA Windermere -29 video DVD. The DVD was turned over as Exhibit #51 for this case file.
