12/19/2012 INTERVIEW OF LINDA VOLL

Summary

On December 19, 2012 S/A Kevi	n Cooper and S/A Jean	-Philippe Rigaud met with Cleveland
Police Dispatcher Linda Voll (DC	OB: 05/13/63, of	West Farmington,

meeting was to gather a statement from Linda Voll regarding the officer involved shooting of

Details

On December 19, 2012 S/A Kevin Cooper and S/A Jean-Philippe Rigaud met with Cleveland Police Dispatcher Linda Voll (DOB: 05/13/63, of West Farmington, Ohio, 44491, Ph. # (cell)). The meeting occurred in Ohio Peace Officer Training Academy Room C113 at 4055 Highlander Parkway, Richfield, Ohio 44286. The purpose of the meeting was to gather a statement from Linda Voll regarding the officer involved shooting of November 29, 2012.

Also present for the interview was Cleveland Police Patrolmen's Association Vice-President, Steve Kinas (1303 West 58th Street, Cleveland, OH 44102 Ph. 216-631-8455)

Voll stated these facts:

Voll is assigned as a dispatcher for C Platoon, night shift (2230-0630 hrs.) for Cleveland Police Department. Voll stated that she has worked for seventeen (17) years. She has rotating days off (V-class). Her supervisors are Sergeant Petranek and Sergeant Tucker. She stated that she is current with all trainings regarding her dispatcher duties.

Voll stated that she felt nervous at the time of this interview.

Voll denies any problems with drug use.

She uses corrective

lenses for reading.

Voll stated that she has been a dispatcher during other vehicle chases and officer involved shootings in her career with Cleveland Police Department. Two (2) of which she mentioned involved the deaths of Officers Clark and AJ Schroeder.

Voll stated that on November 29, 2012:

- She was at the dispatch office ready to work 2230 hrs.
- The Channel 3 dispatcher who she relieved was approximately eight (8) minutes into the chase when Voll took over as dispatcher. She had not listened to the first eight minutes at this point.
- Voll stated that part of her responsibilities that evening was to pull up Channel 2/District 2 radio traffic and broadcast it to Channel 3 officers working District 3. Voll stated she would broadcast all she heard from Channel 2 to Channel 3 accurately.
- At the time she took over the dispatch position, she stated the chase had gone west and heading back towards their District 3.
- Voll stated that the chase was near 25th and Clark, nearing the steel yard, when she took the dispatch position. Channel 2 radio traffic then transmitted that the pursuit was coming east into the 3rd District.
- Voll stated that only one of their District 3 vehicles, 3B35 was part of the pursuit. Voll stated that she maintained radio connection with 3B35. She is not aware as to who the officer was driving that unit.
- Voll stated that she recalls the following radio traffic from Channel 2/District 2:
 - O Vehicle had two (2) occupants. Voll stated she did not believe any further descriptors were broadcast regarding the occupants.
 - o Shots fired from the vehicle
 - o Someone putting a weapon out the window of the vehicle
 - O Description of someone in the vehicle loading a weapon.
 - o A zone car was rammed during the chase
 - O Unknown supervisor from 2nd district inquired into the speed of the chase. As the supervisor was making a second transmission, the supervisor was cut off by other officers.
 - o 'shots fired'
 - o 'watch crossfire'
- Voll stated that she broadcast all of Channel 2 traffic to Channel 3. She further stated that Channel 3/District 3 officers kept radio air clear and did not speak much during the whole incident.
- Voll stated that after Channel 2 traffic stated that a zone car was rammed, she radioed 3B35 to see if further assistance was needed. 3B35 advised her that all was okay.

- Voll stated that after the 'shot fired'/ 'watch crossfire' transmission from Channel 2, she radioed 3B35 who advised that he was too far back to see if anyone was hurt.
- Voll stated that she also heard radio traffic between Sgt. Peters of Car# 9604 and Car#9627. Car #9627 inquired if they should be involved; Voll stated that Sgt. Peters said to let the 3rd and 2nd districts handle it.
- Voll stated that her supervisor told her later in the shift that two (2) subjects were killed. She stated there was no radio traffic regarding the status of the chase's end.
- Voll stated that her supervisor in car S33 responded to the scene in East Cleveland following the chase. Voll stated that a 5th District supervisor requested crime scene to respond to East Cleveland.
- When the pursuit was ended, Voll stated she returned to her Channel 3 duties, sending officers to assignments she had been receiving for her district.
- Voll stated that her sister was the dispatcher for Channel 5/District 5 on November 29th during the time of the pursuit. (Her sister is Robin Vontorcik). Her sister told her in the dispatch room that the 5th district was not putting anyone in the pursuit. Voll stated that she also radioed this information on Channel 3 to her officers.
- Voll stated that she believes a 5th district boss asked for a check for at 205 West St. Clair for a crime scene.
- As the chase was ended, Voll stated she unplugged from Channel 2 and was not aware of any further traffic from that district.
- Voll stated Officer Al Almeida did text her following the pursuit. She stated Almeida
 asking her what time the chase had begun. She stated she did reply with the time of 2231
 hrs. Voll showed S/A Cooper and S/A Rigaud the text on her IPhone. Voll voluntarily
 completed a consent to search form. Voll also willingly took a screen shot of the text
 conversation and emailed it to S/A Rigaud.
- In regards to the radio traffic from District 2, Voll stated that the tone of the officers' voices was higher than other regular chases. Voll stated that the excitement in the officers voices and their yelling were similar to that when officers had been killed during such incidents.
- Voll believes she acted as she was trained to do.

S/A Cooper requested that Voll read and sign the consent form regarding the text from Officer Almeida. Voll allowed S/A Cooper to look at the text on Voll's i-Phone as well. Voll did complete the form. Voll, with the assistance of Cleveland Police Patrolmen's Association Vice-President Steve Kinas, provided a screen shot of the complete text conversation with Almeida. She sent the screen shot to S/A Rigaud's email account.


