Interview of Cleveland Police Officer Kevin Fairchild

Sir

On Monday December 10th 2012 While assigned to Special Investigation in cooperation with Ohio Bureau of Criminal Identification and Investigation and East Cleveland Police. East Cleveland Police Sgt James Ruth and Cuyahoga County Sheriff's office Sgt. Donald Cleland were assigned to interview Cleveland Police Officer Kevin Fairchild in the presence of Union Representative Jeff Follmer, Steve Kinas and Attorney Patrick D'Angelo Interview took place at 4055 Highlander Parkway Richfield Ohio 44286.

Synopsis

At the onset of the interview Officer Fairchild was read his Miranda Rights and the interview continued in the presence of his Attorney and Union Representatives. Background questions were asked by Sgt. Ruth and Sgt Cleland

Assigned unit #288 an unmarked black Ford Crown Victoria. Equipped with lights and siren, spot light (does not work) no MDT, Radio channel 2

Plain Clothed officer on 11/29 wearing black BDU pants, tactical vest and a brown coat Equipment (Firearm) Glock 19 with magazine loaded with 15+1 rounds, Handcuffs, Radio and Tazer. (No personal Weapons)

Part time employment; works at a bar 1 day every other week, and a gas station on weekends. Did not work part time prior to incident of 11/29

Officer Fairchild reports he does not wear Corrective lenses or contacts, and that he is not now nor on the night of 11/29/12 under the influence of Medication, Alcohol, or Drugs.

Details

Sgt Cleland asked how did you become involved in the pursuit of November 29th 2012. Officer Fairchild stated we were in our district, in our office working on reports and evidence from a prior invest when Sgt Coleman came in and said that they were chasing a car that shot at Officer Nan.

I grabbed my vest and the keys to a car, the 288 car and proceeded to the location to try to catch up with the chase. I got involved with the chase around west 45th and Clark.

Sgt Ruth asked did you ever see the car there.

Officer Fairchild stated yea it passed me; he went north because they were on Lorain.

Officer Fairchild continued he first went north on 41st, as he approached I-90 they went south on 85th, he was going to get on the highway thinking they would get on the highway, but they went to Clark. Officer Fairchild came back south on 44th there was a broadcast they were coming up on 44th, Officer Fairchild stated he turned west on 44th and then they came right at him.

Sgt Ruth asked what happened when they came at you.

Officer Fairchild stated I turned around at 46th, Officer Siefer was the lead car and I got behind them Sgt Ruth asked if Officer Fairchild called on the radio to let them know what he was doing Officer Fairchild stated no, I wasn't going to break in while they were broadcasting locations

Sgt Ruth asked if that was all he heard, Broadcast of locations

Officer Fairchild stated yes, I was not on the radio prior to that. Only knew what our sergeant told us happened.

Sgt Ruth asked how long Officer Fairchild stayed in the second car position Officer Fairchild stated all the way to east 79th street.

Sgt Ruth asked what happened there to make you get back or change

Officer Fairchild stated we were on Addison and came down Star by that time I was the lead car, I took over the lead around 72nd and St Clair. I think we went west on Star, I don't know the directions over there. From 79th, Addison towards 79th at 79th he took a really wide turn, I didn't think he was going to make the turn, When I turned onto 79th I was on the inside of them, not next to them but close. As we were going down the street he slammed on the brakes and made a right hand turn on the next street striking the front of my car, at which time I tried to spin out of it. I went left and did not make that turn. I went to the next street and turned right and got back into it

Sgt Ruth asked so he hit you in what area

Officer Fairchild stated the driver's side front with his back right passenger's side.

Sgt Ruth asked what speeds were reached during the pursuit

Officer Fairchild stated we were upwards to the hundreds on the highway; I didn't look much I was by myself so I had to watch for other people.

Sgt Cleland asked what was your best estimate of speed on side streets

Officer Fairchild stated I didn't even look on the side streets; I was focusing on the car and the people in the car. I didn't want to get side swiped by a zone car either.

Sgt Cleland asked if Officer Fairchild had his lights and siren on through the whole period Officer Fairchild stated yes

Sgt Ruth asked if when you were behind the vehicle what did you see the driver or passenger doing

Officer Fairchild stated when we got off at 72nd and went up to St Clair we were staying farther back from the vehicle due to the radio transmission of a gun being pointed out of the back window over off of Quigley, we were keeping our distance keeping out of the line of fire. Coming up 72nd they were going a little bit slower than they had been through most of the chase so I actually got a lot closer. When we got to St Clair there were other district vehicles in that area, I guess they didn't know what way they were going to go with all those cars there so I got pretty much right up on the car.

Officer Fairchild Continued the passenger was "all over the place", going towards the driver reaching back towards the back window and was pulling on the door. When they went off the highway at 72nd I think the door might have popped open it looked like they were pulling on the door trying to make sure it was shut. As we were going down 68th towards Bliss is when I broadcast that I observed a pop can, It was in the right hand the person was completely turned around (demonstrated the movement) body turned to left as far as possible, left arm extended right arm across the body. I could see there were black gloves on the hands so I broadcast that.

Attorney D'Angelo asked what hand he saw the pop can in

Officer Fairchild stated the right hand; the left hand was extended towards the back window. I did nor observe a gun at that time but I did see there were a pair of black gloves on.

Sgt Ruth asked if at this time if Officer Fairchild knew if the subject was male or female. Officer Fairchild stated no, I did not.

Sgt Ruth asked.if when they were leaning back did they motion

Officer Fairchild stated the motion was like a gun, they did not have a gun in their hand but the motion was like they had a gun. I could not tell male of female. The driver stayed very calm very steady he was focused dead on straight .The passenger was all over the place, reaching down reaching over pushing on the driver reaching back again. When I was behind them they must have done it five or six times.

Sgt Ruth asked if Officer Fairchild ever saw the passenger get into the back seat Officer Fairchild stated no

Sgt Ruth asked you never saw a weapon per se just a pop can

Officer Fairchild stated that is correct

Sgt Ruth asked if that was in the right hand

Officer Fairchild stated yes it was red cylinder shaped I perceived it was a pop can.

Sgt Ruth asked Officer Fairchild to continue with the pursuit details

Officer Fairchild stated it was 79th, from 68th and Bliss we went back up 71st to Addison, Addison to 79th I don't know what direction that was. He went to the next right off of 79th I went to the next street. I was passed up and went down to Wade Park. He went up 118, I went up 116 then down Euclid and by the time we went up the hill to the school I was probably the 4th car. I went up the hill, came around and I'm sure there are a lot more questions now.

Sgt Ruth asked you went up the hill and that's were you parked

Officer Fairchild stated I went up the hill and as I went up and over the top of it the first thing I saw was him coming up and over the island in the middle of the parking lot, I don't know how he got turned around in that direction, All I know is he was coming up and over that island, I heard the shots fired, shots I did not know where it came from or who was shooting, I was concentrating on the car itself. I was to the left I came in I stopped on the left hand side.

Sgt Ruth interrupted at this point and placed an aerial map with vehicles overlaid in front of Officer Fairchild. And asked which car are you.

Officer Fairchild identified his vehicle on the aerial map by circling his vehicle

Sgt Ruth asked referencing the map can you follow it on

Officer Fairchild indicated the direction his vehicle was pointing, and said he was probably the 4th car in he pulled to an indicated point and got out of his car, "I knew he was not going to be able to get out with all the cars that were behind us". I ran along here (indicating the curb of the roadway) he drove by me and headed straight for these two cars. (Indicating the subject vehicle passed him on the roadway and continued straight towards zone car 238).

Officer Fairchild continued that the officer in that car (indicating zone car 238) got out of his car I saw the door open he was standing outside his car, At this time I knew he (subject vehicle) was probably going to ram these cars (zone cars 238 & 217) I stopped and ran in this direction (indicating towards zone car 244)when Officer McNeeley was getting out of his car, I grabbed Officer McNeeley and got down in front of this car (indicating zone car 244) because I knew a shooting probably was going to happen and I am not going to run into the line of fire. I got down in front of this car (indicating zone car 233) along with officer McNeeley.

Sgt Ruth asked you said it was back lit could you see anything else

Officer Fairchild stated because there were police cars behind here (indicating the location of zone cars 238 & 217) because I saw a really tall shadow, he's a really tall guy I observed him get out of that car (indicating zone car 238) but did not see the impact with the police car.

Sgt Cleland asked when you first arrived here you said they were coming over the island. Officer Fairchild stated as I was in this area (indicating across from the playground) he was just coming up and over the island. There is a little bit of a hill so I did not see how he got to that point I just saw him coming up and over this way. (Indicating subject vehicle path over the island) I drove up stopped and got out I was running kind of next to the car for a few minutes as it continued on.

Sgt Cleland asked as your car came to rest, you mentioned you heard shots at this point. Officer Fairchild stated yes, the car was in this area (indicating past the island) I stopped there almost next to it.

Sgt Cleland asked if the shots had already been fired at that point

Officer Fairchild stated yes

Sgt Ruth asked when did he hear the first shots

Officer Fairchild stated before I got there, as I was going down (indicating next to the playground) the shots were going, I stopped and got out

Sgt Ruth asked if during the shots did you hear anyone yelling

Officer Fairchild stated that over the radio there was a shots fired call.

Sgt Ruth again asked did you here anyone yelling stop or stop the vehicle or anything like that. Officer Fairchild paused

Sgt Ruth asked if you knew where the shots came from

Officer Fairchild stated no I had no idea where they came from.

Sgt Ruth asked do you remember hearing any officer yelling for the car to stop

Officer Fairchild stated no I don't remember hearing that no.

Sgt Ruth asked as you were running beside the vehicle did you see a weapon at any time Officer Fairchild stated no, I could not see inside the car, not from where I was.

Sgt Cleland asked they drove past you

Officer Fairchild interrupted they drove past me, I came out of the car and was like this to it (indicating running beside it) and they just sped away.

Sgt Cleland asked once you reached this point (indicating zone car 233) you took cover, Was there anything you did until after the gunfire was over with down the road

Officer Fairchild stated no after shots were fired I walked up and made sure everyone was all right, there was a bunch of people all over the place, a couple of people, it looked like a female from vice was going to put handcuffs on the passenger but then someone came up and started getting everyone away from the car. I don't even know who it was.

Sgt Ruth asked if Officer Fairchild ever fired a round Officer Fairchild stated no Sgt Ruth asked why didn't you fire

Officer Fairchild stated there were other cars here in the area if I had fired there was a chance of striking somebody

Sgt Ruth asked if McNeeley was one of the shooters

Officer Fairchild stated he was still in the car when I grabbed him I took him out of the car and pulled him over here (indicating the front of car 233)

Sgt Ruth asked you did not see any weapons, you heard shots but did not know where they were coming from, you grabbed McNeeley and both went down in front of the car. How long before you heard the gunshots go off

Officer Fairchild stated it felt like forever but it wasn't maybe about 6 seconds.

Sgt Ruth asked after everything subsided did you hear anyone saying anything

Officer Fairchild stated they were around the car, they were making sure there was no movement in the car nobody was saying much of anything; I didn't see anything or learn of anything other than the shots.

Sgt Ruth asked if you were down behind the car when the shots were fired Officer Fairchild stated correct

Sgt Ruth asked if Officer Fairchild had any idea who the first officer to shoot was or if the car shot Officer Fairchild stated I have no idea

Sgt Cleland asked if Officer Fairchild could give us an idea what the sound of the gunfire was Officer Fairchild stated a lot, a quick burst sounded almost like an assault rifle, that's how quick they were.

Sgt Ruth asked if Officer Fairchild has been involved in any other shooting incidents Officer Fairchild stated no, I have arrived shortly afterward to assist at scenes but not involved

Sgt Cleland asked if during the time period you were involved in the pursuit from any point where he could see or hear the subject vehicle were there any noises that came from that vehicle Officer Fairchild stated yes around dead mans turn, I heard a loud bang, and I believed the rear tire had blown

Sgt Ruth inquired from the sound you thought the tire had blown

Officer Fairchild stated right there was a bang and a flash it came from the rear tire, Siefer broadcast it first and said the tire blew and I reiterated the point that the rear tire blew. When we came through dead mans it was still inflated and I broadcast I guess he didn't lose a tire. It was a very loud bang pop.

Sgt Ruth asked Officer Fairchild if he had talked to anyone else about this incident Officer Fairchild stated not directly about what happened

Sgt Ruth asked if on scene did you use your cell phone to take any pictures or have you received any pictures

Officer Fairchild stated no all I did was text my wife that I would be late.

Sgt Ruth asked if he was injured at all when the car hit his

Officer Fairchild stated no

Sgt Ruth asked if his actions were consistent with his training

Officer Fairchild stated absolutely

Sgt Ruth asked if the actions of the other officers involved were consistent with their training Officer Fairchild stated absolutely

Sgt Ruth asked if anyone has asked him to lie or attempted to influence his statement to us Officer Fairchild stated no

Sgt Ruth asked how about after the shooting did you do anything like move any objects check any weapons make any calls after the shooting

Officer Fairchild stated no I just waited for them to mark our car so we could drive away.

Sgt Cleland asked who did that

Officer Fairchild stated BCI came and marked our locations

Sgt Ruth asked if he had any prior discipline with Cleveland Police

Officer Fairchild stated no

Sgt Cleland asked if there was anything we did not ask that Officer Fairchild would like to talk about

Officer Fairchild stated I don't think so

Sgt Cleland wanted to clarify one thing, Going around dead mans curve you or someone else thought it was a blown tire. Give me a better description of that. What part of the vehicle did you see the flash

Officer Fairchild stated the passenger rear tire

Sgt Cleland asked you said it was a loud bang

Officer Fairchild stated yes to hear it at 70 going around dead mans it has to be loud

Sgt Cleland asked if Officer Fairchild broadcast that the tire was not blown

Officer Fairchild stated that about 200 feet from dead mans I looked down at the tire again we were in the high speed lane; I had to move over a little bit. I observed the tire did not go flat and broadcast I guess the tire did not blow

Sgt Cleland asked what channel that was on

Officer Fairchild stated channel 2

Sgt Ruth asked about a statement you knew there was going to be a shoot out

Officer Fairchild stated I thought it was inevitable, he was going up the hill quickly and there was nothing but police cars there and knowing there were just shots from down here (indicating on the map the island area) I'm sure they didn't know who just shot; he didn't look like he was going to stop. I saw an officer standing outside the car and he was going right at him

Sgt Ruth asked for Officer Fairchild to sign the map that he had marked his location and referenced throughout the interview

Officer Fairchild complied

Attorney D'Angelo asked if he could take Officer Fairchild through the pursuit and the broadcast Officer Fairchild agreed

Attorney D'Angelo asked about the black glove and the pop can. What were the broadcasts significant to any weapon being involved also what were your observations of the occupants of the suspect vehicle

Officer Fairchild stated when we came off of Clark to Quigley is when there was a broadcast of a weapon out the back window, at that time we backed off a little I was unable to observe that from where I was at. As we were coming down Quigley I even broadcasted to put a spot light on the back window so we can try to observe inside the vehicle. This was done, but the subject vehicle moved to the left out of the spot lights' view. As we went up to 14th to the roundabout there were officers at the top of that hill already in the roundabout as we went through the roundabout and down 14th one of the officers said that he saw a gun at the roundabout, so again the presence of a weapon was still there. We still stayed back on 14th until we got onto the highway

Attorney D'Angelo asked if during this time you could see any movements of the passenger Officer Fairchild stated the passenger was as I said before always moving around and motioning to the back of the car (demonstrated as earlier in interview)

Attorney D'Angelo asked what was your state of mind how did you interpret that Officer Fairchild stated that they were pointing a weapon out the back that's why I asked to put a light on the window to try to see what was going on.

Attorney D'Angelo asked if there was anything remarkable up to the time he broadcast about a pop can

Officer Fairchild stated we all believed there was a gun involved

Attorney D'Angelo asked about the tone of the officers when broadcasting relative to a gun Officer Fairchild stated it was highly iterated that there was a gun in the vehicle

Attorney D'Angelo asked if even after he broadcast that there was a pop can, What was your state of mind relative to the occupants having a weapon

Officer Fairchild stated from what I observed I did not see a weapon at that time as the chase continued there was a broadcast of "Now it looks like they are loading a weapon"

Attorney D'Angelo asked who broadcast that

Officer Fairchild stated my sergeant did, Sgt Coleman

Attorney D'Angelo asked based on that

Officer Fairchild stated based on that he still believed there was a gun in the vehicle

Attorney D'Angelo asked if seeing the pop can excluded the likelihood of the occupants having a weapon

Officer Fairchild stated no

Attorney D'Angelo asked if it was the state of mind that they did have a weapon

Officer Fairchild stated I did not see a weapon, I wanted everyone to know I did not see a weapon at that time, I did not say that there was not one period because I could not see inside the car

Attorney D'Angelo asked about the street where he first heard shots were you still of the belief that there was a weapon in the suspect motor vehicle

Officer Fairchild stated yes

Attorney D'Angelo asked about the point when he was running near the subject vehicle if he entertained firing at the subject vehicle

Officer Fairchild stated my weapon was drawn but I looked over and there were other cars on the other side

Attorney D'Angelo asked if he heard any inappropriate racial remarks at the scene or after Officer Fairchild stated no

Attorney D'Angelo asked if he observed any inappropriate behavior at the scene Officer Fairchild stated no

Attorney D'Angelo asked what speed the subject vehicle was going as it passed coming from the island

Officer Fairchild stated it was pretty fast, it got past me quickly

Attorney D'Angelo asked if at any time he felt that he should notify a supervisor to call off the chase

Officer Fairchild stated no but we did ask for spike strips, the traffic was not that bad there was no real danger to the public I would not have called off the chase.

Sgt Ruth asked if he ever heard them call off the chase

Officer Fairchild stated no

Attorney D'Angelo asked did you believe that when the shooting began that the suspect vehicle was shooting back

Officer Fairchild stated at first I thought they were the ones doing the shooting at the bottom. I was not aware of who was doing what shooting

Attorney D'Angelo asked if based on his training and experience he believed that occupants of the subject vehicle were also firing

Officer Fairchild stated that many shots that quickly, yes

Attorney D'Angelo asked at the time the car went around dead mans curve did you think that was a backfire, would you have broadcast if you thought it was a backfire

Officer Fairchild stated that if I thought it was a backfire I would have broadcast that.

Attorney D'Angelo asked assuming that it was a backfire at dead mans curve, did that change the behavior of the occupants of the vehicle

Officer Fairchild stated no

Attorney D'Angelo asked if backfiring had anything to do with the actions at the island in the parking lot

Officer Fairchild stated no

Attorney D'Angelo asked as a reasonable police officer, did the actions of the occupants of that vehicle indicate they were trying to give up or cause officers to believe they did not have a weapon Officer Fairchild stated no they never made any attempt to stop

Sgt Ruth asked you have been in vice for 7 years have you ever heard of something called the red zone

Officer Fairchild stated only football

Sgt Ruth asked nothing citywide or locally

Officer Fairchild stated no

No prior officer involved shooting incidents

Details

Sgt Cleland asked how Officer Graves first became involved in the incident of November 29, 2012 Officer Graves stated He and his partner Detective Mitchell were in the area of west 41st and Bridge Avenue eastbound on Bridge, they heard a broadcast from Officer Nan of shots fired/vehicle had taken off on him. Officer Graves continued east on Bridge and turned north on West 25th Street as they were approaching Detroit avenue, heard Radio traffic of subject vehicle crossing Detroit Superior bridge. Officer Graves stated that their lights had been activated and they turned left on Detroit Avenue thinking the subject vehicle would be in front of them, in reality the subject vehicle was behind them.

Officer Graves continued that there was a lot of traffic in front of them so he stayed in front of the subject vehicle to try to slow it down, the vehicle stayed behind them till west 45th street. The vehicle turned left on west 45th. Officer Graves continued west because they had passed that intersection, he turned onto to west 48th street and went south. At Lorain Road he went west on Lorain and was second vehicle in Pursuit one marked unit in front of him. At west 85th Street they proceeded south it loops around to Clark Avenue. They continued east on Clark to Quigley Avenue south. Officer Graves stated while on Quigley there was radio traffic of a firearm pointed from subject vehicle. They continued on Ouigley to steelyard drive and back up to West 14th, Down West 14th to the inner-belt. Subject vehicle continued North/East on inner-belt. There were 2 broadcasts that the subject vehicle was attempting to exit the freeway but continued to Dead-mans curve. Officer Graves exited at Superior Avenue believing the subject vehicle was attempting to get to city streets. From the Superior road Exit they continued to St Clair Avenue, Then eastbound on St Clair towards East 72nd they pulled to the curb and heard radio traffic of subject vehicle was traveling south on East 72nd Street. The subject vehicle came off East 72nd west on St Clair then south on east 68th Street. Officer Graves turned onto East 68th and pulled to the curb to allow the zone cars go past. Officer Graves turned around and went back to St Clair Avenue to wait in case of a foot pursuit. Officer Graves stated that the pursuit continued within city streets. He did not really know where he was at but continued east and south based on radio traffic. He heard radio traffic that subject vehicle was going into a dead end, but was not sure of the exact transmission. As they pulled up to the scene they were on a street near by but because they were at the end there were a lot of police cars around and could not drive closer to the scene. Officer Graves stated that as they exited there vehicle they could hear the last of the round going off. Officer Graves and his partner ran up the street to where the police cars were and his partner said to take cover because they did not know were anyone was at that point. Officer Graves stated that as the reached the top of the hill he was concerned because he saw a police car was shot up too, Officer Graves was checking to see if any officers were injured and remained on the scene to help East Cleveland officers tape off the scene.

Sgt Ruth asked what speeds were reached during the pursuit.

Officer Graves stated that on Detroit Road is was around 40 -50 mph, 60-70 mph on Lorain Road, throughout the pursuit Officer Graves said his top speed was 90 mph. When he saw how fast they were going he got off the highway.

Sgt Ruth asked their location at the time of broadcast pointing a gun.

Officer Graves stated that it was south on Quigley going towards Steelyard commons.

Sgt Ruth asked if at any time during the pursuit did you hear a radio broadcast calling off the pursuit. Officer Graves stated no

Sgt Cleland asked what was the closest you were to the suspect vehicle during the pursuit Officer Graves stated they were right behind us on Detroit but after they turned off on 45th they were not that close.

Sgt Ruth asked if Officer Graves saw the driver at all

Officer Graves stated that I looked back in the mirror and could see people moving around but was concentrating on driving, stated he was looking out for the civilians who were in front of us.

Sgt Cleland asked if during the time you were in front of or near the subject vehicle did you hear any sounds coming from that vehicle.

Officer Graves stated no

Sgt Ruth Did you see or hear gunfire from the vehicle during the pursuit Officer Graves stated no

Sgt Cleland asked if Officer Graves saw anything inside the vehicle

Officer Graves no, we were in front of it and when it was in front of us we were too far behind.

Sgt Cleland asked how many cars were between him and the subject vehicle

Officer Graves stated on Lorain just one, after it got farther down Clark avenue more because police cars were actually blocking intersections so civilians would not pull out. Officer Graves continued that honestly he could not tell us because he backed off and pulled off.

Sgt Ruth handed Officer Graves an aerial map of the school lot where the pursuit ended and asked where their car was parked at the end of the pursuit.

Officer Graves stated and indicated that their car was on Terrace road near Wymore at the bottom of the hill, he and his partner ran through the grass, up the hill and saw people standing around, it was a loud and chaotic scene. People were just turning off their sirens, he saw a police car was shot up and was asking if anyone was shot and was checking to see if the officers from that police car were hurt. After learning no officers were hurt he helped "taping" (police caution tape) off the scene.

Sgt Ruth asked how many cars were in the driveway when they arrived.

Officer Graves stated that he could not tell us it looks wider on the map than it really is and 2 cars could not fit side by side, and the cars were staggered in the driveway.

Sgt Cleland asked if the drive was so full of cars that they could not get into it.

Officer Graves stated that they didn't try when they saw the cars parked at the end of the drive. Officer Graves stated he was not going to drive past any police cars we did not know what we were getting into.

Sgt Ruth asked when Officer Graves arrived at the scene what were the actions of the officers he saw.

Officer Graves stated some people were talking but you could not hear what they were saying, it was loud very loud.

Sgt Ruth asked what took place after the sirens were turned off.

Officer Graves stated there were supervisors there and they separated the shooters from everyone else. Sgt Ruth asked if Officer Graves had spoken with any of the officers since then.

Officer Graves stated just one guy, not about this, I don't want to talk about it, I knew there was an investigation, it was this morning he was going to give me directions to get out here.

Sgt Ruth asked if his actions and actions of other officers were consistent with his training.

Officer Graves stated yes

Sgt Ruth asked if anyone asked him to lie or to try to influence his statement.

Officer Graves stated absolutely not

Sgt Cleland asked if at any point did you fire any rounds

Officer Graves stated no

Sgt Cleland ask if there was anything Officer Graves wanted to tell us that we did not ask him Officer Graves stated no, just an unfortunate situation.

Union representative Kinas asked what channel they were on that night

Officer Graves stated Channel 2 and his portable was off.

Union representative Kinas asked if rounds were heard over the sirens at the scene.

Officer Graves stated yes the last few rounds.

Attorney D'Angelo asked what was your state of mind from the point you got involved in the pursuit to the time you got out of the car and ran.

Officer Graves stated honestly, a little scared, cars going by, a little crazy at that point.

Attorney D'Angelo asked what were you concluding based upon the radio traffic you were hearing Officer Graves stated in the beginning I thought they were firing a weapon out of the vehicle. Then the sound of the officer's voice when we got to Quigley that they were pointing a firearm back at policeman was a little hair raising.

Sgt Ruth asked if Officer Graves heard radio traffic that it's not a gun

Officer Graves stated later in the pursuit someone said that it was a pop can but that was way into the pursuit.

Attorney D'Angelo asked what did you conclude from the broadcast about the pop can Officer Graves stated nothing at that point because anyone can have anything at that moment.

Attorney D'Angelo asked what other broadcasts were heard about what the occupant were doing Officer Graves stated they were moving around

Sgt Ruth interrupted to ask did you say you broadcast or you heard.

Officer Graves stated I did make one broadcast at the very beginning My partner had the radio on channel 2 as we got up to west 85th street "I'm correcting myself, I misspoke" I turned my portable to channel 1 because my partner had the car radio on channel 2, to tell channel 1 that we were in it, my car number and that the pursuit was coming to west 85th. Just to let channel 1 know where we were they didn't tie us into the channels.

Attorney D'Angelo asked if after you heard the broadcast about the pop can, did you hear Sgt Coleman broadcast at all.

Officer Graves stated yes, if I recall correctly, I can't remember if it was something about reloading a weapon or, that's what I recall it was shortly after the pop can that there was a broadcast of loading a weapon.

Sgt Ruth stated He (pointing to Attorney D'Angelo) said Sgt Coleman, Did you know who was broadcasting.

Officer Graves stated yes I did she is my boss I recognize the voice, She is my Sergeant.

Attorney D'Angelo asked when you arrived on scene after all the gunshots had been fired what was your impression looking at the faces of officers who were involved in this and their appearance. Officer Graves stated a little disheveled, concerned, scared a little bit some of these people are young

officers and the first shooting they have been in probably

Attorney D'Angelo added you are a senior officer and you indicated you were afraid, is there anything wrong with that.

Officer Graves stated if you are not scared on this job then there is something wrong with you.

Attorney D'Angelo asked if there were any racial comments made at the scene.

Officer Graves stated absolutely not.

Attorney D'Angelo asked if anyone was out of control at the scene

Officer Graves stated no

Sgt Ruth asked for clarification on Sgt Coleman's broadcast

Officer Graves stated I believe it was the passenger was loading a weapon.

Attorney D'Angelo asks to be excused with Officer Graves for a moment.

Attorney D'Angelo returned with Officer Graves and said in the interest of full disclosure he did receive a text message.

Officer Graves stated he received a text message with picture of the scene, not bodies or anything, a picture of the scene from a distance that's it.

Sgt Ruth asked who did that come from.

Officer Graves stated Officer Hummel, it showed the scene from about 30 feet away a few cars and the suspect vehicle.

Sgt Cleland asked if that was on his cell phone

Officer Graves stated correct

Attorney D'Angelo asked when he received the text

Officer Graves stated Friday I was out of town till Monday then I deleted it.

Attorney D'Angelo asked if the text was forwarded to anyone

Officer Graves stated if I did it was once to my Brother I believe, it was a picture of the scene not bodies or anything.

Sgt Ruth asked did you forward it or do you think you forwarded it.

Officer Graves stated I did just one forward that was it.

Sgt Cleland asked what is your 's name

Officer Graves stated

Sgt Cleland asked if his is in law enforcement

Officer Graves stated no

Sgt Cleland asked for his

Officer Graves stated

Sgt Cleland asked if it was forwarded on Monday

Officer Graves stated it was before Monday, He deleted it on Monday

Sgt Cleland asked what day it was sent

Officer Graves stated I'm guessing Friday, to be honest I don't remember what day it was.

Sgt Ruth asked for Officer Graves to sign the map he had marked his location on and Officer Graves complied.



INCIDENT: CPD PURSUIT & OFFICER INVOLVED SHOOTING 11/29/2012

Interview with OSP Trooper Craig Malone

On Thursday, December 13, 2012 at approximately 10:15pm I along with Detective Dave Jacobs conducted an interview with OSP Trooper Craig Malone at the Garfield Post located at 12323 Broadway Garfield Heights, Ohio 44125.

Trooper Malone has been employed with the Ohio State Patrol (OSP) 6 years and currently with the Garfield Post for 2 years. On November 29, 2012 Trooper Malone was assigned to the VGRIP detail in the 5th district. Trooper Malone said he was traveling eastbound on I 90 towards the 5th district when he saw approximately 3 to 4 CPD units pass him along with 6 other police vehicles pass him traveling in the same direction. Trooper Malone initially thought that the police units were responding to an accident so he called his supervisor Lt. Mannion who was also assigned to the VGRIP detail.

Trooper Malone said Lt. Mannion told him that CPD was involved in a pursuit, at that time he heard Sergeant Laughlin (OSP) over the radio say that a subject was armed or possibly armed in the suspect vehicle. Trooper Malone goes on to say that the police units exited E.55th off of I 90 going southbound then they turned left at St. Clair going eastbound and he just followed the cars in front of him. Trooper Malone said he never heard over his radio any direction of travel and he didn't know where everyone was going. Trooper Malone went on to say that he heard dispatch say a CPD Commander terminated the pursuit so he shut down and headed back toward E. 55th.

Trooper Malone said he never heard anything regarding shots fired or why the pursuit started. He also said he never saw the suspect vehicle and that he was never really involved in the pursuit. He only followed the police cars in front of him approximately 2 minutes.

On December 19, 2012 I Detective Sergeant Clifford Pinkney reviewed the recording from the Bratenahl Police Department (BPD) unit 1711 dashcam video that was recorded on November 29, 2012 at approximately 2246 hours.

As the recording starts you can hear radio transmission that they just arrived at the Eddy Road bridge overpass with Cleveland Police Department (CPD) unit 5118. You then hear the dispatcher say that they bailed at E. 72nd. The BPD unit 1711 along with the CPD unit starts to travel on I-90 westbound towards E. 72nd. Both units exited I-90 with lights and sirens activated. Both units fall in behind multiple police units in a pursuit. Some police units make turns down side streets.

BPD unit 1711 pulls over to allow several police vehicles to pass and then BPD unit 1711 falls in behind to continue in the pursuit. All the police vehicles make several turns and continue in the pursuit. At approximately 09:20 you hear a radio transmission say they turned onto Lee Road. At approximately 09:43 into the recording you hear several gun shots as BPD unit 1711 approaches several parked police cars. At approximately 09:47 you hear a male voice possibly BPD unit 1711 say shots fired. At approximately 09:52 the gun shots stop, at approximately 09:53 you can hear 1 (one) gun shot. At approximately 09:56 you can hear several gun shots start again. At approximately 10:01 the gun shots stop and you can hear police sirens in the background. At approximately 10:58 the recording ends.

Bratenahl Police Department dispatcher recording 11/29/2012

On December 19, 2012 I Detective Sergeant Clifford Pinkney reviewed the recording from the Bratenahl Police Department (BPD) Dispatcher recorded on November 29, 2012.

SYNOPSIS:

The Cleveland Police Department (CPD) dispatch called the BPD Dispatch informing them that they were in a high speed chase on I-90 pursuing an older model blue Chevy license plate number FSA 3495. The male operator tells CPD that he was going to transfer the call to BPD dispatch. The CPD dispatch tells BPD that the suspect vehicle was traveling eastbound on I-90 and that they just passed Chester headed towards dead man's curve coming towards Bratenahl. CPD advised BPD that the passenger of the suspect vehicle had a weapon and that they shot at a zone car.

CPD continued to give BPD updates and the direction of travel so that BPD can relay the information to the BPD Officers involved in the pursuit. CPD tells BPD that they did not have a description of the suspects and that the suspect vehicle exited I-90 at East 72nd. CPD also said that the passenger of the suspect vehicle may have bailed and is now on foot on E. 72nd. Both CPD and BPD continued to give their officers updates and the direction of travel of the suspect vehicle. CPD tells BPD that the suspect vehicle hit a zone car at 79th and Addison.

CPD tells BPD that the passenger of the suspect vehicle was reaching for something but they did not know what the passenger was reaching for. They continued to give the direction of travel of the suspect vehicle. CPD tells BPD that the passenger of the suspect vehicle was holding a weapon and was reloading; BPD relayed the message to their officers. At approximately 11:20 into the recording CPD tells BPD that shots had been fired. At approximately 11:43 into the recording BPD unit tells his dispatcher that shots were fired. At approximately 11:53 into the recording both CPD and BPD dispatch ended the call.

As the recording continued you hear one of the BPD units telling the other unit to check in, they then notify dispatch that both units were ok and they have two (2) shot both suspects. At 2303

hours BPD unit 1711 told dispatch they were going to clear the incident. At 2314 both BPD units 1711 and 1714 notified dispatch that they were back in the village.

On December 19, 2012 I Detective Sergeant Clifford Pinkney reviewed the dashcam video from the Bratenahl Police Department unit 1714 recorded on November 29, 2012 at approximately 2246 hours.

As the recording starts Bratenahl Police Department (BPD) unit 1714 is driving and at approximately 00:40 BPD unit 1714 arrives at the Eddy Road bridge overpass and pulls up behind a Cleveland Police Department (CPD) unit 5118. At approximately 00:55 BPD unit 1714 does a U-Turn on the Eddy Road bridge overpass and heads towards I-90 traveling westbound. BPD unit 1714 exits I-90 at East 72nd following a CPD unit with both units having their overhead police lights activated. Both units were traveling southbound on E. 72nd then made a left turn onto St. Clair traveling eastbound. Both units then turned right onto E. 71st traveling southbound. The units then made another left turn traveling eastbound and another right turn onto E. 79th traveling southbound. The units continued traveling southbound until they reached Wade Park. The units made a left turn onto Wade Park traveling eastbound behind several police units.

BPD unit 1714 continued to travel eastbound then made a right turn onto E. 115th traveling southbound. BPD unit 1714 continued then made a left turn onto Euclid Avenue traveling eastbound behind several police units. All of the police units had their overhead lights activated. BPD unit 1714 then made a right turn onto Lee road traveling southbound. At approximately 09:40 BPD unit 1714 parked. At approximately 09:48 two uniformed CPD Officers ran in front of the dashcam video. At approximately 09:51 a CPD vehicle pulls up in front of the parked BPD unit 1714 and the CPD Officer exited the vehicle and ran towards the direction of the other officers. At approximately 10:59 the recording ends.

On Wednesday December 19th 2012 at approximately 1000 hrs. While attempting to locate a subject known only as Tim Noel. Cuyahoga County Sheriff's Office Sergeant Cleland had occasion to interview Henry Banks a resident of 2100 lakeside avenue Cleveland Ohio The interview took place at the Cosgrove center 1736 Superior Avenue (The Cosgrove Center is a Catholic Charities food serving facility for breakfast and lunch meals).

Sgt. Cleland asked if he was the person using the name Tim Noel, Henry Banks said no he is not but was there the night of the 29th.

Sgt. Cleland asked Henry Banks if he could recall the events of November 29th 2012 from the time he saw Timothy Russell's car that night.

Henry Banks stated that he was on "the wall" (an area on the north side of Lakeside Avenue across from the shelter reaching from East 20th to East 22nd street) near east 22nd street the car pulled up and Malissa Williams called him over to the car. He was standing at the driver's side of the car when Vice Officer Jordan pulled up behind them, they pulled away and Jordan followed. Henry Banks stated that they both turned left on east 20th street, he heard the roar of an engine moments later. Officer Jordan returned to the wall and asked "who was in that mother fucking car" and then "don't make mister slappy happy". Henry Banks explained that Officer Jordan carries a slap jack with him and he beats homeless people up with it. Henry Banks stated that Officer Jordan said "I want to know who was at that mother fucking car, buying or selling, I know one of you beige jackets was at the car". Henry Banks stated that no one answered and Officer Jordan said "I'm about to turn it up around here, who's got ID". Henry Banks continued that someone (he did not know who) Said "Malissa is in that car", Officer Jordan asked "who's the guy" again an unknown person said, I don't know they call him Big Man.

Henry Banks could give no further information about the 29th of November but wanted to inform me that Officer Jordan has been harassing Homeless people more after this took place. Henry Banks stated that between 4 days to a week later Officer Jordan pulled him over while walking with 3 other persons on Hamilton Avenue. Officer Jordan and his partner (a black male, hefty with short cut hair) Henry Banks and the 3 others were "put on the hood of the car and their pockets emptied". Henry Banks stated that Officer Jordan said "you can thank Ebony for this". Henry Banks and one other were released the others were taken to jail on warrants. Henry Banks would give no further information.
