12/19/2012 REVIEW OF SURVEILLANCE VIDEO HANINI SUNOCO

Summary

The video reviewed can be identified as item 22 from the BCI Cyber Crimes lab submission (Exhibit #62) and reports to be from a surveillance system located at Hanini Express Sunoco located at12800 Euclid Avenue, East Cleveland, Ohio (216-231-6209.) The person who prepared the video files was Ali Hanini (DOB 4.22.89.) It can be noted that the system in use was identified as an EyeMax. Mr. Hanini exported the requested date range and identified camera to a USB Flash drive after being instructed by SA Lerussi to name the files as a reference to the location address. The USB drive furnished by SA Lerussi. The drive was then secured by SA Lerussi.

SA Lerussi later transferred the files to a CD/DVDR which was labeled item 22. Item 22 can best be described as a CD/DVDR containing 1 folder named "Video", two log text files and a program file. The text files contain documentation and hash values generated from the successful transfer of the files from the USB Drive. The folder contains two color video clips named "12800 euclid ave hanini" and "12800 euclid ave hanini2." The video is of good quality and the lighting is bright.

12800 euclid ave hanini2 reports to be video recorded on 11-29-2012 beginning at 20:30:02:047 recorded by camera 19. This camera appears to face Euclid Avenue and covers the street, the main doors to the store and first set of gas pumps. There are numerous people walking thru the lot, entering and exiting the store during the videos of this location. The below times of events were taken from the embedded time stamp of the video system. The time is dependent on the computer's system clock used to operate the system.

22:48:35:735 A car appears to travel right to left along Euclid Avenue with at a high rate of speed. There is a white SUV parked at the pumps, 3 cars in the parking lot, people entering and exiting the store and foot traffic along the street.

22:49:00:0563 A car drives thru the pumps begins to head towards exit then parks at the far end of the lot.

22:49:31:250 The white SUV leaves pump and tries to exit onto Euclid Avenue turning right, as it does, the first marked patrol cars approach from the left to right along Euclid Avenue with emergency lights activated. One of these cars appears to be all white.

22:50:38:922 Another marked patrol car travels right to left along Euclid Avenue with its emergency lights activated. This car is followed by 3 additional units in the same fashion.

22:50:57:485 Six additional units travel right to left along Euclid Avenue following the other units with emergency lights activated.

22:51:20:438 A white car which had been pulled to curb to allow police cars to pass traveling right to left on Euclid Avenue begins to pull away continuing straight on Euclid Avenue.

22:51:45:797 Two additional marked patrol cars, one appearing white, travel right to left along Euclid Avenue, followed by three additional cars all with their lights activated.

22:53:20:531 A single black and white patrol car travels right to left without its emergency lights activated and at a slower speed than those traveling before it.

12800 euclid ave hanini reports to be video recorded on 11-29-2012 beginning at 20:30:02:281 recorded by camera 19. This camera appears to face Euclid Avenue, it covers all 4 gas pumps from an elevated position, also covering the parking lot nearest the store and the sidewalk adjoining Euclid Avenue. This video, as in the other, displays a large amount of traffic and people walking in the lot and on the sidewalk.

The first marked patrol car comes into view at 22:50:06:453 traveling right to left on Euclid Avenue with its emergency lights activated. Between that time and 22:53:20:531 it is estimated that 37 police units passed thru the video camera all traveling right to left along Euclid Avenue. The last patrol car to do so was a marked black and white unit that traveled slower and without any emergency lights.
