12/19/2012 REVIEW VIDEO FROM EAST CLEVELAND LIBRARY

Summary

On December 19, 2012, SA Moore reviewed three (3) compact discs (CD) containing surveillance footage related to the officer involved shooting regarding the subjects Timothy Russell and Malissa Williams. SA Moore observed one police cruiser in two of the video files, and a line of vehicles which may be part of the pursuit in another video file.

Details

On December 19, 2012, SA Moore reviewed three (3) CDs, each labeled Cyber Crimes Unit, The Ohio Bureau of Criminal Identification & Investigation, CC-12-3-0116, Date: 11-29-12, Agent S/A Warner #135, Video from: East Cleveland Library 14101 Euclid Ave Outdoor Camera.

The first CD is in an envelope named CCU Case Number: CC-12-3-0116, Evidence Item # 5-1. The first CD contains a folder named **20121204**. Within this folder is a folder named **120554**. Within this folder is a folder named **NORMAL** and the file **89080D0F.gpg**. Within this folder are three files, including a video clip named **ch14-01**, **ch14-01.sig**, and **readme.txt**.

The **readme.txt** file contains the following text:

Selected Channel: CH14

The video **ch14-01** is approximately 00:34:04 in length. The video quality is very poor. What may be the police pursuit enters the frame approximately 00:23:56, with the vehicles traveling from the right of the frame to the left. The line of vehicles exits the frame approximately 00:26:38. Approximately 00:27:36, another line of vehicles enters the frame, traveling from the

right of the frame to the left. This line of vehicles exits the frame approximately 00:28:10. Another line of vehicles enters the frame approximately 00:29:49 and exits 00:30:04, traveling from the right of the frame to the left. Approximately 00:30:40, another line of vehicles enters the frame traveling from the right of the frame to the left and exits the frame approximately 00:30:57. At approximately 00:31:40, another line of vehicles enters the frame and exits approximately 00:32:00, traveling from the right of the frame to the left. Between 00:23:56 and 00:32:00, a total of approximately eighty four (84) vehicles are observed traveling from the right of the frame to the left and may be part of the pursuit. An accurate number was difficult to ascertain due to the poor quality of the video surveillance footage.

The second CD is in an envelope named CCU Case Number: CC-12-3-0116, Evidence Item # 5-2. The second CD was not finalized and is an open session. When viewed and exported using forensic software, it was determined that the CD contains a folder named 89077219. Within this folder is a folder named 20121204. Within this folder is a folder named 145107. Within this folder is a folder named NORMAL and a file named 89077219.gpg. Within the folder named normal are two movie files named ch01-01.avi and ch04-01.avi, two files named ch01-01.sig and ch04-01.sig, and readme.txt. The readme.txt file appears to be empty.

The file **ch01-01** is approximately 01:30:52 in length.

Approximately 00:36:56 into the video, a police cruiser passes in front of the camera, traveling from the upper right side of the frame towards the lower left.

The file **ch04-01** could not be viewed.

The third CD is in an envelope named CCU Case Number: CC-12-3-0116, Evidence Item # 5-3. The third CD contains a folder named **20121204**. Within this folder is a folder named **130249**. Within this folder is a folder named **NORMAL** and a file named **89077219.gpg**. Within this folder are two movie files named **ch01-01** and **ch04-01**, two files named **ch01-01.sig** and **ch04-01.sig**, and **readme.txt**.

The **readme.txt** file contains the following text:

Selected Channel: CH01 CH04

The file **ch01-01** is approximately 00:31:52 in length.

Approximately 00:07:13 into the video, a police cruiser passes in front of the camera, traveling from the upper right side of the frame towards the lower left.

The file **ch04-01** is approximately 00:31:50 in length.

No evidentiary items were located within **ch04-01**.
