Summary

The video reviewed can be identified as item 26 from the BCI Cyber Crimes lab submission (Exhibit #63) and reports to be from a surveillance system located at the GAS USA (216-579-9343) located at located at 3101 Scranton Road, Cleveland, Ohio. The gas station is located on the corner of Scranton Avenue and Clark Avenue. The person who was identified as the owner and who had control of the video system was Jim Soliman (DOB 12.18.52.) It can be noted that the system was operated by the store owner; however, the actual video files were exported from the system by SA Lerussi as the owner did not have the ability to perform the task. The files were copied to USB thumb drive and secured by SA Lerussi.

Item 26 can be described as a CD/DVD containing 24 files, 22 of which are video files. The other 2 files are log text files documenting the successful transfer from the flash drive of the video files and the corresponding hash values. The date and time covered by the exported files cover 2012-11-29; 2025 hrs. until and including 2012-11-29; 2305 hrs. Only one camera view was provided, the camera faces the street which appears to be Clark Avenue.

The video is in an avi format and playable with VLC Media Center. The video clips are small in size and move rapidly. Viewing may be difficult if not slowed down with a media player.

At 2340 hrs. a vehicle moves rapidly left to right through the video screen, it is blurry and difficult to distinguish. At 2343 hrs. at least 2 marked patrol cars with overhead lights activated follow the direction of the first car left to right as well. The remaining portion of this video and the other files do not depict anything related to the investigation.
