<u>Cuyahoga County Sheriff's office</u> Attempt to Locate, Identify and Interview Tim Noel

December 19th 2012

Sir

On Wednesday December 19th 2012 at approximately 0800 hours, Sergeant Cleland attempted to locate a subject known only as Tim Noel (reported to be a resident of the homeless shelter at 2100 Lakeside avenue Cleveland Ohio). Tim Noel gave a statement to the Cleveland Plain Dealer regarding the events of 11/29/2012; Sergeant Cleland was attempting to contact Tim Noel to see what additional information he may have regarding the traffic stop made by Officer Jordan on that night. Cuyahoga County Sheriff's Office Sergeant Donald Cleland questioned individuals at the Cosgrove center 1736 Superior Avenue. A large majority of residents of the shelter at 2100 Lakeside are fed breakfast and lunch at the Cosgrove center, the probability of locating Tim Noel would be high as a rapport with the staff of this facility is present.

Upon arrival, Sergeant Cleland first spoke with Ms. Vanhorn, dining room supervisor, and handles the check in of each person eating at each meal. Ms. Vanhorn said that the name Tim Noel is not in there system and was not known to her.

Ms. Terrell Valentine, human services worker, Cosgrove Center, was asked if she was aware of a Tim Noel or anyone who may have used that name. Ms. Valentine stated that she does not recognize that name or know of anyone using that name.

CMHA police Officer Manuel Leon was working as an off duty part time officer at the Cosgrove center. Sergeant Cleland asked if he knew of any person using the name Tim Noel who may be at the Cosgrove center. Officer Leon stated that he had never heard that name and believed it to be a false name used by a resident to hide there identity.

Sergeant Cleland identified himself to a number of the clients of the Cosgrove center who stay at the shelter at 2100 Lakeside Avenue, most had little to say other than "I'm not talking to no police". One individual later identified as Henry Banks claimed to know about Officer Jordan's actions on the night of 11/29/2012 but was reluctant to talk.

Ebony Hall has been an open informant and has a trusted relationship with the homeless community. Sergeant Cleland spoke with Ebony Hall regarding Tim Noel, Ebony Hall stated that she knows who spoke to the Plain Dealer and that Tim Noel is a fictitious name. The man who gave the statement to the media believes he has warrants and will not meet face to face with police. Ebony hall would not provide the subjects name but advised that she will talk to him about giving a statement by telephone. Ebony Hall was provided a business card with Sergeant Cleland's contact information for the subject known as Tim Noel.

Ebony Hall was also advised if Sergeant Cleland is not available to contact Sergeant James Ruth whom she has also shared information. A statement was taken from Henry Banks by Sergeant Cleland, at the time of this report there has been no contact from the person known as Tim Noel.
