REVIEW OF RTA BUS STOPS VIDEO FROM BELMORE/118th

Summary

On December 21, 2012 Special Agent Perry Roeser was handed a compact disc (CD-R) from Special Agent Mark Kollar that needed reviewed. The disc was marked with two locations, E118 St and Belmore. SA Roeser was advised that the disc contained images from cameras at the RTA bus stop hubs on the city streets from Cleveland, Ohio. SA Roeser advised he would assist. This video was obtained on December 12, 2012 by Detective James Mackey from the Cuyahoga County Sheriff's Office (see attached report).

Details

On December 21, 2012 SA Roeser reviewed one compact disc that contained two locations on the streets of Cleveland Ohio. Both video cameras were affixed to poles that were aimed at RTA bus hubs where pedestrians gather prior to the arrival of approaching buses.

The first scene was labeled (E 118 East View-21). The start time and date on the video was posted as 11/29/2012 with a start time of 10:45 PM. The camera was angled to specifically point at an RTA covered hub. The camera angle view showed what appeared to be an intersection which showed four lanes of travel (two lanes each in opposite directions).

At 10:47 PM a portion of the suspect vehicle was viewed turning left onto the street headed into potentially oncoming traffic. Portions of police cruisers were viewed following/chasing the suspect vehicle. The video concluded at 11:00 PM hours.

No other evidentiary images were viewed on the camera angle named E 118 East view-21.

The second video on the CD-R was labeled (Belmore East-28). The camera was affixed to a pole and also viewed an RTA covered hub where pedestrians gather prior to approaching RTA buses.

The date and start time on the video was 11/29/2012 at 10:49:39 PM. The camera view depicts a 4-lane roadway with traffic flow in both directions. There was a turn lane in the center of the roadway.

At 10:49:39 the suspect vehicle came into view with police cruisers chasing it. The speed of the chase at the camera angle didn't seem excessive. There were three cruisers side by side following the suspect vehicle down the street. As the suspect vehicle passed the camera view a silhouette of two individuals could be seen in the driver and passenger seats.

A steady flow of police cruisers were viewed following the suspect vehicle and most of them had the overhead lights activated. A few of the cruises toward the end of the procession did not have the overhead lights activated. The parade of cruisers continued until approximately 11:00 PM. From 11:00 PM to the conclusion of the video which ended at 11:37:24 hours police cruisers with and without overhead lights on were viewed intermittently.

This video was obtained on December 12, 2012 by Detective James Mackey from the Cuyahoga County Sheriff's Office (see attached report).
