12/21/2012 REVIEW OF SURVEILLANCE VIDEO GAS CITY

Summary

On December 12, 2012 SA Lerussi was assigned to assist in the investigation of an Officer Involved Shooting and Police Pursuit by review of surveillance video obtained from various locations and sources along the reported route the pursuit traveled. The assignment was to review the video files and to provide a summary of any activities observed relating to the pursuit and or shooting.

Details

On December 12, 2012 SA Lerussi was assigned to assist in the investigation of an Officer Involved Shooting and Police Pursuit by review of surveillance Video obtained from various locations and sources along the reported route the pursuit traveled. The assignment was to review the video files and to provide a summary of any activities observed relating to the pursuit and or shooting

On December 21, 2012, SA Lerussi reviewed surveillance video from the Gas City, West 14th and Clark. The video files reviewed can be identified as two (2) CD-R Imation 700 MB Disks Labeled as Gas City West 14th/Clark, 3074 W 14th Street (Camera 6 and Camera 4); 12-20-2012; EPL/136; CC-18-12-82-1513, and reports to be from a surveillance system from Gas City located at 3074 West 15th Street, Cleveland, Ohio (216-781-2248.) The person identified as the manager and who was contacted by SA Lerussi was Nader Salen (DOB 4-8-82.) Mr. Salen allowed SA Lerussi to view the system and to export the requested date range from cameras identified as being of interest to a USB flash drive prepared by SA Lerussi and into a folder labeled with the location's name created on the drive. The drive was then secured in by SA Lerussi. SA Lerussi later transferred the files onto two (2) CD-Rs which were labeled as described above. The video is of good quality and the lighting is bright.

Camera 4. Appears to be mounted on the front corner of the Clark Avenue side of the station; it shows Clark Avenue in the extreme right of the view as well as the intersection of 14th Street in the upper right corner of the view. There are 18 video files which begin at 10:29 PM with the last file beginning at 11:03 PM. The file named "Event201229223953004" was created on November 29, 2012 at 10:44 PM. In this file, several police vehicles with emergency lights activated can be seen traveling along Clark Avenue to the intersection of 14th Street. Some vehicles can be seen traveling straight through the intersection, some turn right onto 14th Street and one vehicle can be seen approaching Clark from 14th Street and then turn left onto Clark, approach the station, and travel out of view in the opposite direction.

Camera 6. Appears to be mounted on the opposite front side of the station and faces 14th Street and the gas pumps. There are 21 video files exported from this camera. The first file begins at 10:27 PM and the last file was created at 11:04 PM. All 21 files were reviewed and no identifiable police cars were observed on any of the video files.
