REVIEW UNIVERSITY CIRCLE VIDEO RECORDING

Summary

On December 24, 2012 S/A Brenda McNeely reviewed a video recording titled "University Circle Bldg. 12100 Euclid Ave (CC-12-03-0116)" from S/A Rick Warner #135. The recording is dated 11-29-12 and is marked CCU evidence item 11 (Exhibit #91).

Details

The video recording marked evidence #11 in case CC-12-03-0116 appeared to be an exterior camera labeled camera #6 beginning on 11-29-2012 at 22:50:57 hours to 23:09:19 hours. The viewing area of the camera is a parking lot surrounded by Coltman Road on the left of the camera's viewing area or southwest side and Euclid Avenue in the background or the northwest side.

At 22:59:18 a vehicle is observed entering the camera's viewing area from the west to southwest direction on Euclid Avenue and continuing in a northeasterly direction. The vehicle is immediately followed by eleven police units with emergency lights activated. The vehicle exits the camera's viewing area at 22:59:22 hours and the eleventh police unit exits the viewing area at 22:59:38 hours. Two seconds later, eight more police units pass through on Euclid Avenue with emergency lights activated. Between 23:00:15 and 23:00:30 hours, three more police units proceed in the same direction with emergency lights activated. Eleven more police units pass through in the same direction at 23:00:55 hours and 23:02:01 hours, all with their emergency lights activated. A 23:03:10 hours, an additional police unit with emergency lights activated, passes through traveling in the same direction as the previous units. At 23:03:44, another police unit with emergency lights activated is observed traveling northeasterly on Euclid Avenue and exits the camera viewing area at 23:03:50. The last police unit with emergency lights activated

and traveling in the same direction as the other units was observed passing through on Euclid Avenue at 23:04:44 hours, exiting the viewing area of the camera at 23:04:48 hours. A total of thirty-six (36) marked police units with emergency lights activated are observed between 22:59:18 hours and 23:04:44 hours, pursuing the vehicle in question.

A marked police unit, consistent with Cleveland Police Department marked units, is observed traveling northeasterly on Euclid Avenue with no emergency lights activated. It enters the parking lot of the camera viewing area, 12100 Euclid Avenue. The marked unit drives around the parking lot and then exits back onto Euclid Avenue at 23:06:17. His direction of travel is unknown.
