CCU ANALYSIS REPORT





Summary:

On December 12, 2012, Special Agent Eric Lehnhart from the Ohio Bureau of Criminal Investigation received consent to search the contents of a mobile phone from James L Hummel. Said item was subsequently forwarded to BCI Cyber Crimes Unit Richfield, Ohio for analysis. This item is to be analyzed for evidence pertaining to the crime of Officer Involved Shooting regarding the subjects Timothy Russell and Malissa Williams.

Submitted Items:

EV20: EV20 is best described as an Apple manufactured mobile phone model iPhone A1429. The serial number associated with EV20 is . EV20 conforms to the Code Division Multiple Access (CDMA) standard. CDMA is one of two competing standards for mobile phones in the world. In addition to making and receiving phone calls, EV20 is capable of text messages, pictures, video, playing audio files, e-mail, browsing websites, and instant messaging. This phone also has approximately 16 Gigabytes (GB) of internal storage and it is not capable of additional storage.

EV20SIM1: EV20SIM1 is best described as a Verizon Wireless manufactured Subscriber Identity Module (SIM) card bearing the manufactured serial number

Findings:

EV20: Attachment P contains seven (7) spreadsheets that detail information from **EV20.** These spreadsheets include: calendar events, calendar notes, call history, contacts, device general information, device network information, and SMS (Short Message Service) messages. It is necessary to note that calls and SMS messages that occurred between November 29, 2012 2200 hours and December 14, 2012 1340 hours are highlighted in yellow. Attachment Q contains nineteen (19) MMS (Multimedia Messaging Service) messages stored upon **EV20.** It is necessary to note MMS messages 1 through 7 contain graphic images that appear to depict scenes from the incident that occurred on November 29, 2012. These images are also appended for review as **Attachment R**. The Exchangeable Image File Format (EXIF) data embedded within these graphic images indicate said images were created by an Apple manufacturer model iPhone 5 mobile phone. **Attachment S** contains two (2) video files, ninety (90) voicemails, and
