

# Ohio Bureau of Criminal Investigation

## CCU ANALYSIS REPORT





#### **Summary:**

On December 5, 2012, Special Agent Jean-Philippe Riguad from the Ohio Bureau of Criminal Investigation received a warrant to search the contents of two (2) mobile phones. Said items were subsequently forwarded to BCI Cyber Crimes Unit Richfield, Ohio for analysis. These items are to be analyzed for evidence pertaining to the crime of Officer Involved Shooting regarding the subjects Timothy Russell and Malissa Williams.

### **Submitted Items:**

EV2: EV2 is best described as a LG manufactured mobile phone model LG-VN150PP bearing the serial number . EV2 conforms to the CDMA (Code Division Multiple Access) standard. CDMA is one of two competing standards for mobile phones in the world. EV2 is branded for Verizon Wireless service. In addition to making and receiving phone calls, EV2 is capable of text messages, pictures, video, playing audio files, e-mail, browsing websites, and instant messaging. This phone also has approximately 76.7 MB (Megabytes) of internal storage and it is not capable of additional storage.

EV3: EV3 is best described as Kyocera manufactured mobile phone model 10-R727A-01 bearing the MEID (mobile equipment identity) number . EV3 conforms to the CDMA standard and is branded for Access Wireless service. In addition to making and receiving phone calls, EV3 is capable of text messages, playing audio files, e-mail, browsing websites, and instant messaging. This phone also has approximately 85.9 MB of internal storage and it is not capable of additional storage.

#### **Findings**:

**EV2: EV2** is assigned the phone number . **Attachment F** contains two (2) spreadsheets that detail information from **EV2.** These spreadsheets include: call history and contacts. **Attachment G** contains thirty-four (34) graphic files stored upon **EV2**. **Attachment H** contains forty-five (45) screen captures that detail **EV2's** general information and text messages.

**EV3: EV3** is assigned the phone number . **Attachment I** contains two (2) spreadsheets that detail information from **EV3.** These spreadsheets include: contacts and SMS (Short Message Service) messages. **Attachment J** contains fifty-one (51) graphic files stored
