**COUNT 1 – ENGAGING IN A PATTERN OF CORRUPT ACTIVITY**

THE JURORS OF THE GRAND JURY OF THE State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about November 28, 2017 to on or about June 26, 2019 at Washington County, Ohio, or another county whereby venue is properly placed in Washington County and State of Ohio, PATRICK LOUIS WILSON, employed by, or associated with, any enterprise, knowingly conduct or participated in, directly or indirectly, the affairs of the enterprise through a pattern of corrupt activity or the collection of an unlawful debt, Logan Madison Construction, Twin Building Supply, C&M Construction and Wilson Contracting, did conduct or participate in, directly or indirectly, the affairs of the enterprise through a pattern of corrupt activity, to wit: the criminal acts separately charged in Counts 2 through 70 of this Indictment, as if fully re-written herein, the total amount of the property involved being in excess of one thousand dollars, a felony of the first degree, in violation of Section 2923.32(A)(1) of the Revised Code, and against the peace and dignity of the State of Ohio.

**COUNT 2 – TELECOMMUNICATIONS FRAUD**

THE JURORS OF THE GRAND JURY OF THE State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about November 28, 2017 to on or about June 26, 2019 at Washington County, Ohio, or another county whereby venue is properly placed in Washington County and State of Ohio, PATRICK LOUIS WILSON, having devised a scheme to defraud, knowingly disseminated, transmitted, or caused to be disseminated or transmitted by means of a wire, radio, satellite, telecommunication, telecommunications device, or telecommunications service any writing, data, sign, signal, picture, sound or image, to wit: Facebook Posts and Messages with purpose to execute or otherwise further the scheme to defraud, and the value of the benefit obtained by the defendant or the detriment to the victim or victims of the fraud is one hundred fifty thousand dollars or more but less than one million dollars, a felony of the second degree, in violation of Section 2913.05(A) of the Revised Code, and against the peace and dignity of the State of Ohio.

**COUNT 3 – THEFT FROM A PERSON IN A PROTECTED CLASS**

THE JURORS OF THE GRAND JURY OF THE State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about April 1, 2019 at Washington County, Ohio, or another county whereby venue is properly placed in Washington County and State of Ohio, PATRICK LOUIS WILSON, did with purpose to deprive the owner of certain property or services worth one thousand dollars or more but less than seven thousand five hundred dollars, to wit: \$5,459 US Currency belonging to KENNETH DILLON, knowingly obtained or exerted control over such property or services beyond the scope and at the time, the said victim was an elderly person, a felony of the fourth degree, in violation of Section 2913.02(A) of the Revised Code, and against the peace and dignity of the State of Ohio.

**COUNT 4 – THEFT FROM A PERSON IN A PROTECTED CLASS**

THE JURORS OF THE GRAND JURY OF THE State of Ohio, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that on or about April 1, 2019 at Washington County, Ohio, or another county whereby venue is properly placed in Washington County and State of Ohio, PATRICK LOUIS WILSON, did with purpose to deprive the owner of certain property or services worth one thousand dollars or more but less than seven thousand five hundred dollars, to wit: \$5,459 US Currency belonging to KENNETH DILLON, knowingly obtained or exerted control over such property or services by deception and at the time, the said victim was an elderly person, a felony of the fourth degree, in violation of Section 2913.02(A) of the Revised Code, and against the peace and dignity of the State of Ohio.
